DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the so-called dwelling-house of the Rev. Archbell near Thaba Nchu, surrounded by two metres of land, to be a national monument.

Description

The dwelling-house, known as the Rev. Archbell's house, surrounded by two metres of land, situate on Erf 7, Thaba Nchu (now known as Farm 745, Thaba Nchu), and measuring 6 morgen 503 roods. Deed of Grant, dated 9 August 1886.

Historical and Architectural Interest

After the Barolong tribe had moved from Platberg to Thaba Nchu in 1833, the church and the Rev. Archbell's mission house were reerected here. Between 1836 and 1839 this house of the Rev. Archbell was probably enlarged.

Beskrywing

Die woonhuis, bekend as eerw. Archbell se huis, met twee meter grond daaromheen, geleë op Erf 7, Thaba Nchu (nou bekend as Plaas 745, Thaba Nchu), en groot 6 morg 503 roede. Grondbrief gedateer 9 Augustus 1886.

Historiese en Argitektoniese Belang

Na die verhuising van die Barolongstam vanaf Platberg na Thaba Nchu in 1833, is die kerk en eerw. Archbell se sendinghuis hier heropgerig. Tussen 1836 en 1839 is hierdie huis van eerw. Archbell waarskynlik vergroot.
