Kragtens artikel 92 van die Kinderwet, 1960 (Wet 33 van 1960), gelees met Proklamasie 303 van 1972, wysig ek, Schalk Willem van der Merwe, Minister van Kleurlingbetrekkinge en Rehoboth-aangeleenthede, hierby die regulasies afgekondig by Goewermentskennisgewing R. 236 van 21 Februarie 1964, soos gewysig, soos volg:

(a) Regulasie 153 (1) word deur die volgende regulasie vervang:

"153 (1) Behoudens die bepalinge van regulasie 154, mag geen lyfstraf, ontneming van voorregte of ander straf van ernstige aard sonder die goedkeuring van die prinsipaal of superintendent of 'n beampte wat namens hom in sy afwesigheid optree, toegedien word nie."

(b) Regulasie 154 word deur die volgende regulasie vervang:

"154. Lyfstraf mag nie aan 'n dogter toegedien word nie, tensy die prinsipaal of superintendent van die betrokke inrigting, veiligheidsplek, plek van bewaring of waarnemingsentrum spesiale goedkeuring daarvoor gevra en ontvang het van die Sekretaris."

(c) Regulasie 156 word deur die volgende regulasie vervang:

"156. Lyfstraf word op die sitvlak toegedien met 'n rottang of gladde ligte lat en geen ander soort liggaamstraf mag sonder die goedkeuring van die betrokke distriks-geneesheer toegedien word nie."

AMENDMENT OF REGULATIONS UNDER THE
CHILDREN'S ACT, 1960 (ACT 33 OF 1960)

Under section 92 of the Children's Act, 1960 (Act 33 of 1960), read with Proclamation 303 of 1972, I, Schalk Willem van der Merwe, Minister of Coloured Relations and Rehoboth Affairs, hereby amend the regulations published under Government Notice R. 236, dated 21 February 1964, as amended, as follows:

(a) The following regulation is substituted for regulation 153 (1):

"153 (1) Subject to the provisions of regulation 154, corporal punishment, withholding of privileges or other punishment of a serious nature shall not be administered without the approval of the principal or superintendent or an officer acting on his behalf during his absence."

(b) The following regulation is substituted for regulation 154:

"154. Corporal punishment shall not be administered to a girl unless the principal or superintendent of the institution, place of safety, place of detention or observation centre concerned has asked for and received special approval therefor from the Secretary."

(c) The following regulation is substituted for regulation 156:

"156. Corporal punishment shall be inflicted on the buttocks with a cane or smooth light switch and no other form of corporal punishment shall be administered without the approval of the district surgeon concerned."
