Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Johannes Petrus van der Spuy, Minister van Nasionale Opvoeding, hierby die historiese woonhuis te Rhebokskraal, naby McGregor, tesame met vyf meter grond daaromheen, tot nasionale gedenkwaardigheid.

*Beskrywing*

Die Kaaps-Hollandse huis, bekend as Rhebokskraal, met vyf meter grond daaromheen en geleë op sekere vrygekoopte erfpaggrond in die afdeling Robertson, synde die restant van die plaas Rhebokskraal B en groot 1,217 2 hektaar.

*Argitektoniese Belang*

Hierdie gewelhuys dateer uit 1874 en is een van die beste voorbeelde van die laaste fase van die Kaaps-Hollandse boustyl. Naas die Kaaps-Hollandse elemente, het hierdie woonhuis ook tipiese karaktertrekke van die Georgiëanse en Victoriaanse style, soos die interessante anneks en bo-ligte.

**RESERVATION OF LAND FOR THE PURPOSE OF A TOWNSHIP**

The State President has, in terms of section 184 of the Mining Rights Act, 1967 (Act 20 of 1967), reserved for the purpose of a township a portion of proclaimed land, approximately 5 555 square metres in extent, situate on the farm Doornfontein 92 IR, District of Johannesburg, Mining District of Johannesburg, Province of the Transvaal, registered in the name of City Deep Ltd, and as shown on a sketch plan, copies of which have been filed in the Mining Titles Office, Johannesburg, and in the office of the Mining Commissioner, Johannesburg, under RMT R53/74.

**DECLARATION OF A NATIONAL MONUMENT**

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the historic homestead at Rhebokskraal, near McGregor, together with five metres of land surrounding it, to be a national monument.

*Description*

The Cape-Dutch house known as Rhebokskraal, surrounded by five metres of land and situate on certain piece of redeemed quitrent land in the Division of Robertson, being the remainder of the farm Rhebokskraal B and measuring 1,217 2 hectares.

Deed of Transfer 367/1973, dated 10 January 1973 (paragraph 1).

*Architectural Interest*

This gabled house dates from 1874 and is one of the best examples of the last stages of the Cape-Dutch architectural style. Apart from the Cape-Dutch elements, this dwelling-house also has typical characteristics of the Georgian and Victorian styles, such as an interesting annex and fanlights.
