Education, hereby declare the remains of the Indigo Vats,
Pinetown, with a portion of the surrounding erf, to be a
national monument.

Description

The historical property with the Indigo Vats thereon,
including a portion of Erf 3079, Pinetown, in the Natal
Division, as shown on a map filed with the Natal
Provincial Administration and on File 18/N/P-T/1 of the
National Monuments Council, and measuring in its
entirety 0,743 acres. Deed of Transfer 7936, dated
27 October 1959.

Historical Interest

These vats were constructed by two Dutch immigrants,
Colenbrander and Van Pohn, and were used between
1854 and 1856 for the manufacture of indigo dye.
