DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property, known as the Christus Kirche, Windhoek, South-West Africa, to be a national monument.

*Description*

The property known as Erf 132, Windhoek, with the Christus Kirche thereon, in the District of Windhoek, South-West Africa, and measuring as such 446 sq. metres. Deed of Replacement Title 1256/1967, dated 22 August 1967.

*Historical interest*

The Christus Kirche in Windhoek, South-West Africa, was designed by Gottlieb Redecker and was officially consecrated in 1910.

NATIONAL MONUMENT, RORKE'S DRIFT.—EXTENSION OF AREA

By virtue of section 10 (2) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, hereby amend Government Notice 292 of 7 March 1969 by including the land mentioned below in the battlefield of Rorke's Drift.

*Description*

The figure A.B.C.D.E.F.G.H. represents 5,812.2 hectares of land of the battlefield or Rorke's Drift on Subdivision 2 of the farm Mchjeaane 2254, situate in the County of Klip River, Province of Natal, surveyed in September 1973 by Surveyor D. E. K. Simpson and shown on Map SG 4104/1973.

*Historical interest*

This area was the focal point of the battle or Rorke's Drift which took place on 22 January 1879.

*Historiese belang*

Hierdie terrein was die brandpunt van die slag van Rorke's Drift wat op 22 Januarie 1879 plaasgevind het.
