Beskrywing

Sekere stuk grond met die historiese geboue daarop, geleë in die munisipaliteit McGregor, afdeling Robertson, synde Erf 375, 'n gedeelte van Erf 8, McGregor, en groot tweeduizend eenhonderd een-en-veertig (2 141) vierkante meter.

Historiese en argitektoniese belang

Hierdie twee huisies in die volksboukundige styl dateer uit die tweede helfte van die negentiende eeu. Die eiendom vorm in sy geheel 'n belangrike argitektoniese element van die historiese kern van McGregor. (10/2/403.)

Beskrywing

Sekere opgehefte erfpaggrond met die historiese Munisipale Kantore daarop, geleë in die munisipaliteit McGregor, afdeling Robertson, synde die resterende gedeelte van Erf 81, McGregor, 'n belasbare gebied in die McGregorbesproeiingsdistrik, en groot as sodanig eenhonderd vier-en-tagtig (184) vierkante roede vier-en-sestig (64) vierkante voet.

Transportakte 15242/1965, gedateer 15 Junie 1965.

Historiese en argitektoniese belang

Die Munisipale Kantore is geleë in die middel van McGregor en bestaan uit 'n gewelhuys en 'n Georgiïaanse anneks, wat beide uit ongeveer 1870 dateer.

Die gewelhuys is 'n verteenwoordigende voorbeeld van die laaste opflikkering van die Kaaps-Hollandse boustyl. Die Georgiïaanse anneks is 'n dubbelverdiepinggebou. Tesame vorm hierdie geboue 'n interessante eenheid en 'n belangrike argitektoniese element in die historiese kern van McGregor. (10/2/405.)

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare Erf 375, McGregor, with the historic buildings thereon, to be a national monument.

Description

Certain piece of land with the historic buildings thereon, situate in the Municipality of McGregor, Division of Robertson, being Erf 375, a portion of Erf 8, McGregor, and measuring two thousand one hundred and forty-one (2 141) square metres.

Deed of Transfer 15327, dated 30 May 1974.

Historical and architectural interest

These two cottages in the vernacular style date from the second half of the nineteenth century. The property in its entirety forms an important architectural element of the historic centre of McGregor. (10/2/403.)

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the property with the historic Municipal Offices thereon, in Voortrekker Street, McGregor, to be a national monument.

Description

Certain abolished quitrent land with the historic Municipal Offices thereon, situate in the Municipality of McGregor, Division of Robertson, being the remaining extent of Erf 81, McGregor, a rateable area in the McGregor Irrigation District, and measuring as such one hundred and eighty-four (184) square roods sixty-four (64) square feet.

Deed of Transfer 15242/1965, dated 15 June 1965.

Historical and architectural interest

The Municipal Offices are situated in the centre of McGregor and consists of a gabled house and a Georgian annex, both of which date from about 1870.

The gabled house is a representative example of the last flickering of the Cape Dutch architectural style. The Georgian annex is a double-storeyed building. These buildings together form an interesting unit and an important architectural element of the historic centre of McGregor. (10/2/405.)
