DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare 15 historic houses in Artillery Street, Defence Headquarters, Pretoria, being Nos 1 to 15 inclusive, Artillery Street, to be a national monument.

Description

Fifteen historic houses in Artillery Street, Defence Headquarters, Pretoria, being:

(i) Nos 1 to 13 inclusive, Artillery Street, situate on the remainder of the farm Pretoria Townlands 351 JR, in the District of Pretoria, Province of the Transvaal.

Certificate of Registered Title 60/1907, dated 12.1.1907.

(ii) Nos 14 and 15 Artillery Street, situate on Portion 260 of the farm Pretoria Town and Townlands 599, in the District of Pretoria, Province of the Transvaal.

Certificate of Registered Title 8424/1959 [paragraph (1)], dated 11 April 1959.

Historical and architectural interest

Nos 1 to 15 Artillery Street were built during the nineties of the nineteenth century by the Government of the old South African Republic as homes for officers and non-commissioned officers of the "Staatsartillerie".

These houses form a unique architectural and military historical complex. It is important that the whole street facade be preserved.

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare Erf 602, King William's Town, with the historic Methodist manse thereon, to be a national monument.

Description

Certain piece of abolished quitrent land, being Erf 602, King William's Town, situate in the Borough of King William's Town, in the Division of King William's Town, and measuring as such 741 (seven hundred and forty-one) square metres. Deed of Transfer T1131/1974, dated 4 June 1974.

Historical and architectural interest

The old Methodist manse was built in approximately 1855. It is a simple, double-storeyed building with a corrugated iron roof and a wooden balcony which stretches from one side of the front facade to the other. Together with the neighbouring old Methodist church it forms an interesting architectural and historic group.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Johannes Petrus van der Spuy, Minister van Nasionale Opvoeding, hierby 15 historiese huise in Artilleriestraat, Verdedigingshoofkwartier, Pretoria, synde Artilleriestraat 1 tot en met 15, tot nasionale gedenkwaardigheid.

Beskrywing

Vyftien historiese huise in Artilleriestraat, Verdedigingshoofkwartier, Pretoria, synde:

(i) Artilleriestraat 1 tot en met 13, geleë op die restant van die plaas Pretoria Dorpsgronde 351-JR in die distrik Pretoria, provinsie Transvaal.

Sertifikaat van Geregistreerde Titel 60/1907, gedateer 12.1.1907.

(ii) Artilleriestraat 14 en 15, geleë op Gedeelte 260 van die plaas Pretoria Dorp en Dorpsgronde 599 in die distrik Pretoria, provinsie Transvaal.

Sertifikaat van Geregistreerde Titel 8424/1959 [paragraaf (1)], gedateer 11 April 1959.

Historiese en argitektoniese belang

Artilleriestraat 1 tot 15 is gedurende die negentigerjare van die negentiende eeu deur die Regering van die Zuid-Afrikaansche Republiek gebou as woonhuise vir offisiere en onderoffisiere van die Staatsartillerie.

Hierdie huise vorm 'n unieke argitektoniese en militêre historiese kompleks. Die hele straatbeeld is vir bewaring van belang.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Johannes Petrus van der Spuy, Minister van Nasionale Opvoeding, hierby Erf 602, King William's Town, met die historiese Methodiste pastorie daarop, tot nasionale gedenkwaardigheid.

Beskrywing

Sekere stuk afgeskafte erfgrond, synde Erf 602, King William's Town, geleë in die munisipaliteit King William's Town, in die afdeling King William's Town, en groot as sodanig 741 (sewehonderd een-en-veertig) vierkante meter. Transportakte T1131/1974, gedateer 4 Junie 1974.

Historiese en argitektoniese belang

Die ou Methodiste-pastorie is in ongeveer 1855 opgerig. Dit is 'n eenvoudige dubbelverdiepinggebou met 'n sinkdak en 'n houtbalkon wat van die een kant van die voorfasade na die ander strek. Tesame met die aangrensende ou Methodistekerk vorm dit 'n interessante argitektoniese en historiese kompleks.
