DECLARATION OF A NATIONAL MONUMENT
 By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare Clark House and Victoria Hall, with 30 metres of land on the north-western side and 40 metres of land on the south-western side of the buildings, situated at Maritzburg College, Pietermaritzburg, to be a national monument.

Description
Clark House and Victoria Hall, with 30 metres of land on the north-western side and 40 metres of land on the south-western side of the buildings, situate on the remainder of Lot 80 of the Town Lands of Pietermaritzburg, and measuring as such 42,287 6 cres. Deed of Transfer 98/1862, dated 19/2/1862.
<i>Historical and architectural interest</i>
Clark House was erected in 1887 and the adjoining Victoria Hall in 1895. These buildings housed the original Pietermaritzburg High School.
Clark House itself is built in the Neo-Gothic style and is one of the best-known school buildings in South Africa.

<i>Historiese en argitektoniese belang</i>
Clarkhuis is in 1887 en die aangrensende Victoriasaal in 1895 opgerig. Hierdie geboue het die oorspronklike Pietermaritzburg-hoërskool gehuisves.
Clarkhuis self is in die neo-Gotiese styl gebou en is een van die bekendste skoolgeboue in Suid-Afrika.

Description

Historical and architectural interest

The Longmarket Street Girls' School building was erected between 1903 and 1911. The building shows a plurality of architectural styles and is a fine and rare example of a Victorian school building.
