DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the permanent buildings, including the Institute building, the Rector's house, the hall and the ablution block, on the site of the historic Grey Institute, situate on Erf 2580, Port Elizabeth, to be a national monument.

Description

The permanent buildings, including the Institute building, the Rector's house, the hall and the ablution block, on the site of the historic Grey Institute, situate on Erf 2580 (formerly known as a certain piece of land situate in Belmont Terrace, Port Elizabeth, being subdivision School Erf of the divided land granted to the Board of Managers of the Public Schools of Port Elizabeth upon the Grey Foundation on 10 December 1856) and measuring as such two hundred and fifty (250) square roods. Deed of Transfer 7534/1908, dated 19 October 1908.

Historical and architectural interest

The establishment of the Grey Institute is closely associated with the introduction of organised education in the Cape Province under the administration of Sir George Grey. The buildings of the Grey Institute are in the neo-Gothic style and form an essential part of the appearance and character of the historic core of Port Elizabeth. 10/2/29.

Description

The historic fort, situate on Erf 354, Uniondale [previously known as certain piece of land being the remaining extent of a portion of the subdivided farm Rietvalley, in the Division of Uniondale (formerly George)] and measuring one hundred and twenty-seven (127) morgen, sixty-one (61) square roods and sixty-three (63) square feet.

Deed of Transfer 4458/1895, dated 10 August 1895.

Historical and architectural interest

This historic fort was erected during the Anglo-Boer War by the British military authorities and the so-called Town Guards for the defence of Uniondale.

Four similar structures were built at the time at Uniondale. These fortifications differed considerably from other forts in the Karoo and along the West Coast. 10/2/470.

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the Church Square with the historic Dutch Reformed Mother Church thereon, at Senekal, to be a national monument.

Description

The Church Square, with the Dutch Reformed Mother Church thereon, at Senekal, consisting of—

(1) Erf 284 (formerly known as "een zeker stuk grond of Droog Erf No. 284") situate in the town of Senekal and measuring two hundred and seventy-seven (277) square roods and one hundred and twelve (112) square feet;

(2) Erf 324, situate in the town of Senekal and measuring three hundred and forty-seven (347) square roods and thirty-two (32) square feet.

Deeds of Transfer 24259/1881, dated 21 January 1881 (Erf 284), and 11894/1905, dated 25 February 1905 (Erf 324).

Historical and architectural interest

This historic church building was designed by the architects J. H. and A. E. Till and built in sandstone by the contractors Rowe, Marshall and Hill. The building was consecrated in 1896.

The Church Square is enclosed by a wall on which fossil tree trunks were placed in the forties. 10/2/479.

Historiese en argitektoniese belang

Hierdie historiese fort is gedurende die Anglo-Boereoorlog deur die Britse militêre owerhede en die sogenaamde "Town Guards" vir die verdediging van Uniondale opgerig.

Historiese en argitektoniese belang
