DESCRIPTION.

The Bridge of Five Arches, Waterval-Onder: The bridge and the surrounding area, as shown in diagram L.G. No. A.5293/61, surveyed by Land Surveyor A. J. le Roux in October–November, 1959, February, 1960, and September, 1961.

HISTORICAL INTEREST.

The bridge is a particularly fine stone structure and was originally built for the Z.A.S.M. railway line between Pretoria and Lourenco Marques.

RIET RIVER GOVERNMENT WATER SCHEME.—
RAISING OF WATER QUOTA FOR THE
WATER YEAR 1ST APRIL, 1963, TO 31ST
MARCH, 1964.

The Minister of Water Affairs has, in terms of sub-sections (2) (b) and (3) of section *sixty-three* of the Water Act, 1956 (Act No. 54 of 1956), determined that the full normal water quota of seventy-six (76) cusec-hours per scheduled morgen be allocated for the water year 1st April, 1963, to 31st March, 1964.
