DECLARATION OF THE CITY HALL, NEWCASTLE

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the historic city hall, Newcastle, situate on Lot 433, Newcastle Township, an unregistered subdivision of the remainder of Lot 1, Newcastle, to be a national monument.

*Description*

The historic city hall, Newcastle, situate on Lot 433, Newcastle Township, an unregistered subdivision of the remainder of Lot 1, Newcastle, Province of Natal. Deed of Transfer 938/1897, dated 15 June 1897.

*Historical and architectural interest*

The city hall was designed by William Lucas and erected in 1898. It is one of the few remaining colonial buildings in Newcastle. 10/2/527.
