Ingevolge artikel honderd agt-en-twintig, gelees met artikel honderd ses-en-twintig van genoemde Wet, begaan enige persoon wat wilens en wetens engeen van vermeldde publikasies in sy besit het of daarmee handel, 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van tweeduizend rand, of met gevangenisstraf vir 'n tydperk van hoogstens vyf jaar of met sowel die boete as die gevangenisstraf.

In terms of sub-section (1) of section twenty-one of the Customs Act, 1955, the said publications are, therefore, prohibited from importation into the Republic.

In terms of section one hundred and twenty-eight, read with section one hundred and twenty-six of the said Act, any person who knowingly has in his possession or deals with any such publications shall be guilty of an offence and liable on conviction to a fine of two thousand rand, or to imprisonment for a period not exceeding five years, or to both such fine and imprisonment.

Die Rynse Kerk, Stellenbosch:—

- (a) Sekere stuk eiendomsgrond grensend aan die eiendom van die Sendinggenootskap op die Parade of „King's Square”, nou bekend as Erf No. 668, Stellenbosch, geleë in die Munisipaliteit en Afdeling Stellenbosch, groot 60 vierkante roede 71 vierkante voet.
- (b) Seker stuk grond grensend aan die eiendom van die Sendinggenootskap op die Parade of „King's Square”, nou bekend as Erf No. 669, Stellenbosch, geleë in die Munisipaliteit en Afdeling Stellenbosch, groot 65 vierkante roede 90 vierkante voet.

HISTORIESE BELANG.

Die Rynse Kerk, in 1823 opgerig en in 1840 vergroot, is een van die oudste sendingkerke in Suid-Afrika.

PROCLAMATION OF A MONUMENT.

By virtue of the powers vested in me by paragraph (a) of sub-section (1) of section eight of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), as amended, I hereby proclaim the Rhenish Church, Stellenbosch, to be an historical monument.

DESCRIPTION.

The Rhenish Church, Stellenbosch:—

- (a) Certain piece of freehold land bordering on the property of the Missionary Society on the Parade or „King's Square”, now known as Erf No. 668, Stellenbosch, situate in the Municipality and Division of Stellenbosch, measuring 60 square roods 71 square feet.
- (b) Certain piece of land bordering on the property of the Missionary Society on the Parade or „King's Square”, now known as Erf No. 669, Stellenbosch, situate in the Municipality and Division of Stellenbosch, measuring 65 square roods 90 square feet.

HISTORICAL INTEREST.

The Rhenish Church, built in 1823 and enlarged in 1840, is one of the oldest mission churches in South Africa.
