NATIONAL MONUMENTS ACT (ACT 28 OF 1969)

DECLARATION OF ERF 173, CLANWILLIAM

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the property, being Erf 173, with the old church building of the Dutch Reformed Church thereon, at Clanwilliam, to be a national monument.

Description

The property, with the old church building of the Dutch Reformed Church thereon, being certain piece of land situate in the Municipality and Division of Clanwilliam, being Erf 173, Clanwilliam, and measuring 1 898 (one thousand eight hundred and ninety-eight) square metres.

Deed of Transfer 28417/1973, dated 1 October 1973.

Historical and architectural interest

This church building was designed in the neo-Gothic style by Carl Otto Hager, the well-known architect. Hager also supervised its erection, which was completed about 1864. 10/2/619.
