Beskrywing

Die gebou bekend as "Publicity House", geleë op sekere stuk grond bekend as Onderverdeling A van "Market Square" van die Dorpsgronde van Pietermaritzburg, in Pietermaritzburg, Natal.

Historiese en argitektoniese belang

Hierdie gebou met sy indrukwekkende ingang is deur J. S. Brunskill ontwerp en in 1884 voltooi. Dit het die dorpspolisie tot 1927 en daarna die Suid-Afrikaanse Polisie tot 1933 gehuisves, toe dit deur die Publikiteitsvereniging bekom is. Tesame met die Stadssaal en Hoogeregshof vorm die gebou 'n belangrike historiese en argitektoniese gebouegroep. 10/2/630.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Willem Adriaan Cruywagen, Minister van Nasionale Opvoeding, hierby die eiendom met die historiese Kaaps-Hollandse woonhuis daarop, geleë te De Jonghlaan 7, Paarl, tot nasionale gedenkwaardigheid.

Beskrywing

Die eiendom met die historiese woonhuis daarop, synde sekere grond geleë in Paarl, synde Erf 7030, 'n gedeelte van Erf 2314, Paarl, en groot 1 217 (eenduisend tweehonderd-en-sewentien) vierkante meter.

Transportakte 4505/1978, gedateer 10 Maart 1978.

Historical and architectural interest

This dwelling-house has an interesting combination of vernacular and Georgian characteristics and dates from the mid-nineteenth century. The single-storey rear section probably predates the original grant of land made in 1839. 10/2/629.

NATIONAL MONUMENTS ACT, No. 28 OF 1969

DECLARATION OF THE PUBLICITY HOUSE
BUILDING AT PIETERMARITZBURG

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the so-called "Publicity House" building in Pietermaritzburg to be a national monument.

Description

The building known as "Publicity House", situate on certain piece of land known as Subdivision A of "Market Square" of the Townlands of Pietermaritzburg, in Pietermaritzburg, Natal. Crown Grant 12509/1935, dated 12 February 1935.

Historical and architectural interest

This building with its imposing entrance was designed by J. S. Brunskill and completed in 1884. It housed the Borough Police until 1927 and thereafter the South African Police until 1933, when it was acquired by the Publicity Association. Together with the City Hall and the Supreme Court this building forms an important historical and architectural group of buildings. 10/2/630.

DECLARATION OF THE CAPE DUTCH DWEL-
LING-HOUSE AT 7 DE JONGH AVENUE, PAARL

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the property with the historic Cape Dutch dwelling-house thereon, situated at 7 De Jongh Avenue, Paarl, to be a national monument.

Description

The property with the historic dwelling-house thereon, being certain land situate in Paarl, being Erf 7030, a portion of Erf 2314, Paarl, and measuring 1 217 (one thousand two hundred and seventeen) square metres.
