Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Willem Adriaan Cruywagen, Minister van Nasionale Opvoeding, hierby die Nederduitse Gereformeerde Kerkgebou, Rustenburg, tot nasionale gedenkwaardigheid.

*Beskrywing*

Die Nederduitse Gereformeerde Kerkgebou, Rustenburg, synde geleë op sekere Erf 1877, geleë aan Pleinen Burgersstraat, in die dorp Rustenburg, en groot 1,405 6 morg.

Sertifikaat van Gekonsolideerde Titel 16788/1962, gedateer 13 Augustus 1962.

*Historiese en argitektoniese belang*

Bouwerk aan hierdie neo-Gotiese kerkgebou het in 1898 begin, maar weens die uitbreek van die Tweede Vryheidsoorlog kon die afrondingswerk eers in 1903 gedoen word. Tydens die oorlog is die gebou deur die Britte as hospitaal gebruik en na bewering het ses gewonde Britse soldate die Victoriakruis in die kerk ontvang. In 1974 is dit smaakvol gerestoureer en veral die interieur is indrukwekkend. 10/2/632.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Willem Adriaan Cruywagen, Minister van Nasionale Opvoeding, hierby Erwe 910 en 933 met die geboue bekend as die "Union Tavern", asook die stalle daarop, te Simonstad, tot nasionale gedenkwaardigheid.

*Beskrywing*

Die eiendom met die sogenaamde "Union Tavern", asook die stalle daarop, synde—

(a) sekere stuk grond geleë in die munisipaliteit Simonstad, afdeling Kaap, synde Erf 910, Simonstad, en groot 476 vierkante meter; en

(b) sekere stuk grond geleë soos hierbo, synde Erf 933, Simonstad, en groot 350 vierkante meter.

Transportakte 4174/1975, gedateer 24 Desember 1975.

*Historical and architectural interest*

This stonework church with stained glass windows was designed by Sophie Gray. The foundation stone was laid in 1850 and the church was consecrated in 1855 by Bishop Gray. 10/2/583.

DECLARATION OF DUTCH REFORMED CHURCH BUILDING, RUSTENBURG

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the Dutch Reformed Church Building, Rustenburg, to be a national monument.

*Description*

The Dutch Reformed Church Building, Rustenburg, being situated on certain Stand 1877, situate on Plein and Burgers Streets, in the town of Rustenburg, and measuring 1,405 6 morgen.

Certificate of Consolidated Title 16788/1962, dated 13 August 1962.

*Historical and architectural interest*

Construction on this neo-Gothic church building started in 1898, but owing to the outbreak of the Anglo-Boer War the finishing touches could only be done in 1903. During the war the building was used by the British as a hospital and it is alleged that six wounded British soldiers received the Victoria Cross in the church. In 1974 it was tastefully restored and the interior is particularly impressive. 10/2/632.

DECLARATION OF THE UNION TAVERN AND STABLES AT SIMONSTOWN

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare Erven 910 and 933, with the building known as the "Union Tavern", as well as the stables thereon, at Simonstown, to be a national monument.

*Description*

The property with the so-called "Union Tavern", as well as the stables thereon, being—

(a) certain piece of land situate in the Municipality of Simonstown, Cape Division, being Erf 910, Simonstown, and measuring 476 square metres; and

(b) certain piece of land situate as above, being Erf 933, Simonstown, and measuring 350 square metres.

Deed of Transfer 4174/1975, dated 24 December 1975.

*Historiese en argitektoniese belang*

Hierdie gebou is in 1801 as 'n herberg deur Johannes Bissinger opgerig. Dit is later ook as hotel gebruik.

*Beskrywing*

Die eiendom met die Georgiense dubbelverdiepinggebou daarop, synde sekere stuk grond, geleë in die munisipaliteit en afdeling Stellenbosch, synde die resterende gedeelte van Erf 655, Stellenbosch, en groot 971 vierkante meter.

*Historiese en argitektoniese belang*

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the property with the historic Dutch Reformed Church Building thereon, in Church Street, Worcester, to be a national monument.

*Description*

The property with the historic Dutch Reformed Church Buildings thereon, being the remainder of Erf 481, Worcester, and measuring 3,403 4 morgen.

Deed of Grant Vol. 4—Folio 1, Worcester Freehold, dated 18 December 1829.

*Historical and architectural interest*

This Gothic cruciform church, the cornerstone of which was laid on 7 February 1831 by the Civic Commissioner of Worcester, P. J. Truter, was consecrated on 3 February 1832. 10/2/605.

DECLARATION OF THE PROPERTY WITH THE GEORGIAN HOUSE THEREON, AT 108 DORP STREET, STELLENBOSCH

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the property with the Georgian double-storeyed building thereon, at 108 Dorp Street, Stellenbosch, to be a national monument.

*Description*

The property with the Georgian double-storeyed building thereon, being certain piece of land situate in the Municipality and Division of Stellenbosch, being the remaining extent of Erf 655, Stellenbosch, and measuring 971 square metres.

Deed of Transfer 197/1977, dated 14 January 1977.

*Historical and architectural interest*

The original part of this historic house dates from the beginning of the nineteenth century and was later adapted to the Georgian style. It forms an integral part of the architecturally and historically important street scene of Dorp Street, 10/2/651.
