Beskrywing

Die terrein synde Erf 317 en sekere gedeeltes van Erwe 316, 318 en 319, soos getoon op Landmeterskaart 5/8465/14 van 14 April 1973, geliasseer by die kantore van die Munisipaliteit van McGregor en die Raad vir Nasionale Gedenkwaardighede op Lêer 2/K/M-G/5 en as volg beskryf:

(a) Sekere stuk grond, 'n belasbare oppervlakte in die McGregor-besproeiingsdistrik, geleë in die munisipaliteit McGregor, afdeling Robertson, synde Erf 317, McGregor, en groot vierduisend tweehonderd drie-en-tagtig (4 283) vierkante meter.

DECLARATION OF ERF 317 AND PORTIONS OF ERVEN 316, 318 AND 319, MCGREGOR

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the site being Erf 317 and certain portions of Erven 316, 318 and 319, McGregor, with the houses in the vernacular style thereon, to be a national monument.

Description

The site being Erf 317 and certain portions of Erven 316, 318 and 319, as shown on Surveyor's Diagram 5/8465/14, dated 14 April 1973, and filed at the offices of the Municipality of McGregor and at the National Monuments Council on File 2/K/M-G/5 and described as follows:

(a) Certain piece of land, a rateable area in the McGregor Irrigation District, situate in the Municipality of McGregor, Division of Robertson, being Erf 317, McGregor, and measuring four thousand two hundred and eighty-three (4 283) square metres.

Deed of Transfer 10691/1970, dated 27 April 1970 (paragraph 2).

(b) Certain piece of land, a rateable area in the McGregor Irrigation District, situate in the Municipality of McGregor, Division of Robertson, being Erf 316, McGregor, and measuring one decimal two eight four eight (1,284 8) hectares.

Deed of Transfer 10691/1970, dated 27 April 1970 (paragraph 1).

(c) Certain piece of land, being the remainder of Erf 318, McGregor, situate in the Municipality of McGregor, Division of Robertson, a rateable area in the McGregor Irrigation District and measuring four hundred and seventeen (417) square metres.

Deed of Transfer 7885/1971, dated 25 March 1971.

(d) Certain piece of land, a rateable area in the McGregor Irrigation District, situate in the Municipality of McGregor, Division of Robertson, being Erf 319, McGregor, and measuring six hundred and fifty-three (653) square metres.

Deed of Transfer 10691/1970, dated 27 April 1970 (paragraph 3).

Historical and architectural interest

This strategically situated site forms an integral part of the historic core of McGregor. The 28 housing units on the site were erected in 1976 in the traditional vernacular style by means of a subsidy from the National Monuments Council. 10/2/388.
