DECLARATION OF ERF 4589 WITH THE STRUCTURE KNOWN AS FORT AMIEL THEREON, AT NEWCASTLE

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare Erf 4589, with the structure known as Fort Amiel thereon, at Newcastle, to be a national monument.

*Description*

The property with the structure known as Fort Amiel thereon, being Lot 4589 Newcastle (Extension 22), situate in the Townlands of Newcastle, Klip River Division, Province of Natal, and measuring nine thousand nine hundred and seventy-three (9 973) square metres.

Deed of Transfer 4138/1973, dated 16 March 1973 (paragraph 1).

*Historical and architectural interest*

This structure was named after Major Ameil and was erected in about 1878. It was used by British soldiers during the Zulu Rebellion and the First War of Independence. 10/2/393.

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Willem Adriaan Cruywagen, Minister of National Education, hereby declare the property with the building known as the "Ou Pastorie" thereon, situated at 141/143 Dorp Street, Stellenbosch, to be a national monument.

*Description*

The property with the historic building known as the "Ou Pastorie" thereon, namely certain piece of land being the remaining extent of Erf 1141, Stellenbosch, situate in the Municipality and Division of Stellenbosch, and measuring as per remaining extent two thousand seven hundred and sixty-six (2 766) square feet.

*Helmteken.*—Voor 'n blou staf getop deur 'n kruis en omwonde van twee toegewende rooi slange, 'n rooi antieke dubbeloor lampie gevlam met 'n goue agtpuntige ster.

*Historiese en argitektoniese belang*

Die eiendom met die historiese gebou bekend as die Ou Pastorie daarop, te wete seker stuk grond synde die resterende gedeelte van Erf 1141, Stellenbosch, geleë in die munisipaliteit en afdeling Stellenbosch en groot soos per resterende gedeelte tweënduisend sewehonderd ses-en-sestig (2 766) vierkante voet.

*Historical and architectural interest*

The original portions of this Cape Dutch house date from the middle of the eighteenth century and it was first used as parsonage for the Rev. Meent Borchers. The property forms an essential part of the traditional architectural street scene of Dorp Street, and thus also of the historic core of Stellenbosch. 10/2/670.

**GROOT RIVER GOVERNMENT WATER CONTROL AREA, DIVISIONS OF WILLOWMORE, STEYTLERVILLE, UITENHAGE AND HUMANS-DORP, CAPE PROVINCE.—NOTICE IN TERMS OF SECTION 63 (4) OF THE WATER ACT, 1956 (ACT 54 OF 1956)—DETERMINATION OF THE MAXIMUM EXTENT OF LAND WHICH MAY BE IRRIGATED**

I, Abraham Jacobus Raubenheimer, in my capacity as Minister of Water Affairs, determine, in terms of sections 63 (2) (a) and 63 (2A) of the Water Act, 1956 (Act 54 of 1956), that the maximum extent of land in the Groot River Government Water Control Area which may be irrigated with water from a Government water work is as follows, provided that such land can, in the opinion of a Scheduling Board appointed by me in terms of section 64 (1) of the said Water Act, be irrigated beneficially:

(a) Twenty-five comma seven (25,7) hectares per owner plus five (5) per cent of the balance of the irrigable area of his property(ies), as registered in the office of the Registrar of Deeds on the date of the inclusion thereof in the Government Water Control Area; or
