Beskrywing

Die Setlaarshuisie met 5 meter omliggende grond, asook die Setlaarsfortifikasie met 5 meter omliggende grond, geleë op sekere stuk afgeskafte erfpaggrond, genoem Hilton, synde die restant van die plaas Hilton, geleë in die afdeling Cathcart en groot sewehonderd agt-en-sewentig (778) morg sewe-en-sewentigduisend agthonderd nege-en-sewentig (77 829) vierkante voet. Transportakte 2875/1960, gedateer 2 Maart 1960.

Historiese en argitektoniese belang

Hierdie Setlaarshuisie is in ongeveer 1853 deur John Miles opgerig. Vanaf 1867 is dit ook vir Metodistekerkdienste gebruik. Die nabyleeë fortifikasie dateer uit dieselfde tydperk as die Setlaarshuisie en is opgerig as verdedigingsentrum vir die eienaar en sy bure. 10/2/697.

**DECLARATION OF THE SETTLER'S COTTAGE
 AND THE SETTLER'S FORTIFICATION ON THE
 FARM HILTON, DISTRICT OF CATHCART**

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the Settler's cottage together with 5 metres of surrounding land, as well as the Settler's fortification with 5 metres of surrounding land, on the farm Hilton, in the District of Cathcart, to be a national monument.

Description

The Settler's cottage with 5 metres of surrounding land, as well as the Settler's fortification with 5 metres of surrounding land, situate on certain piece of extinguished quitrent land, called Hilton, being the remainder of the farm Hilton, situate in the Division of Cathcart, and measuring seven hundred and seventy-eight (778) morgen seventy-seven thousand eight hundred and twenty-nine (77 829) square feet.

Deed of Transfer 2875/1960, dated 2 March 1960.

Historical and architectural interest

This Settler's cottage was erected in about 1853 by John Miles. From 1867 it was also used for Methodist church services. The nearby fortification dates from the same period as the Settler's cottage and was erected as a defence centre for the owner and his neighbours. 10/2/697.

**DECLARATION OF ALBERTYN'S COTTAGE,

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the building known as Albertyn's Cottage, at Simonstown, to be a national monument.

Description

The building known as Albertyn's Cottage, situate on certain piece of land in the Municipality of Simonstown in the Cape Division, marked No. 3, and measuring one hundred and ninety-three (193) square rods eighty (80) square feet.

Deed of Transfer 4996/1923, dated 26 June 1923.

Historical and architectural interest

This cottage was built by Alexander Tennant between 1799 and 1801. 10/2/701.
