

*Description*

Certain piece of land, with the City Hall Complex thereon, being the eastern portion of Market Square (now known as Erf 5110), situate in the town of Johannesburg, in the District of Johannesburg (Transvaal), measuring one (1) morgen fifty-three (53) square roods. Crown Grant 517/1910 (T18327/78), dated 12 October 1910.

*Historical and architectural interest*

The corner-stone of the City Hall Complex was laid on 29 November 1910 by the Duke of Connaught and Strathearn and the building was officially opened on 7 April 1915 by Governor-General Lord Buxton. It was designed in a grandiose Edwardian Baroque style, and is a good example of the pomp expected of this type of building before the First World War. Stylistically it is strikingly counterbalanced by the adjoining Rissik Street Post Office. 10/2/716.

DECLARATION OF THE HISTORIC POWDER MAGAZINE IN GELDERBLOM STREET, SWELLEDAM

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the historic powder magazine in Gelderblom Street, Swellendam, to be a national monument.

*Description*

The historic powder magazine situated on certain piece of land, being the remainder of Erf 1386, Swellendam, situate in the Municipality and Division of Swellendam and measuring nine hundred and eighty-four (984) square metres.

*Historical and architectural interest*

This simple rectangular powder magazine dates from the middle of the nineteenth century and was possibly erected by the well-known firm, Barry and Nephews. 10/2/717.

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the property with the historic house known as The Retreat thereon, situated at 1 Prince Alfred Street, Grahamstown, to be a national monument.

*Description*

The property with the historic house known as The Retreat thereon, being certain piece of land situate in the Municipality of Grahamstown, Division of Albany,

*Historiese en argitektoniese belang*

Die hoeksteen van die Stadhuis-kompleks is op 29 November 1910 deur die Hertog van Connaught en Strathearn gelê en die gebou is op 7 April 1915 deur Goewener-generaal Lord Buxton amptelik geopen. Dit is ontwerp in 'n indrukwekkende Eduardiaanse Barok-styl en is 'n goeie voorbeeld van die praal wat vóór die Eerste Wêreldoorlog van hierdie tipe geboue verwag is. *Beskrywing*

Die eiendom met die historiese huis bekend as The Retreat daarop, synde sekere stuk grond geleë in die munisipaliteit Grahamstad, afdeling Albany, synde Erf

being Erf 6334 (portion of Erf 3188) Grahamstown, and measuring three hundred and fifty-three (353) square metres, and now part of Consolidated Erf 6335 Grahamstown.

*Historical and architectural interest*

This property was transferred to Piet Retief on 16 July 1821. It is presumed that he built the oldest portion of this building, although the remaining portion of the double-storeyed house dates from the eighteenth-forties. Another prominent pioneer of the Eastern Cape, Major Charles Selwyn, owned the property from 1841 to 1848. 10/2/714.

COTTAGE AT CLANWILLIAM

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the Irish Settler cottage, together with five metres of surrounding land, at Clanwilliam, to be a national monument.

*Description*

The Irish Settler cottage, together with five metres of surrounding land, situated on a portion of erven 28 and 29, being certain redeemed quitrent land, situate in the Municipality and Division of Clanwilliam.

Deed of Transfer 15276/1967, dated 11 July 1967 (paragraphs 3 and 4).

*Historical and architectural interest*

This Settler cottage dates from the early nineteenth century and represents the vernacular building style used by the Irish Settlers of the eighteen-twenties. 10/2/722.

*Description*

The remains of the historic Huguenot Memorial School, with five metres of surrounding land, situate on certain piece of land, being Portion 1 of the farm Kleinboschkop Annex 637, situate at Dal Josafat, in the Division of Paarl.
