Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Teunis Nicolaas Hendrik Janson, Minister van Nasionale Opvoeding, hierby die sogenaamde Joodse Skuinshuis, geleë te Van Ryneveldstraat 44, Stellenbosch, tesame met 'n omringde gebied wat die historiese hoenderhokke insluit, soos vollediger hieronder beskryf, tot nasionale gedenkwaardigheid.

*Beskrywing*

Die eiendom met die Joodse Skuinshuis en hoenderhokke daarop, soos getoon deur die argitek G. T. Fagan as die figuur ABCDEFGHIJA op Kaart 7405/1, geliasseer in die kantore van die Registrateur van Aktes en van die Raad vir Nasionale Gedenkwaardighede in Kaapstad, geleë op sekere stuk grond in die munisipaliteit en afdeling Stellenbosch, synde Erf 4296, Stellenbosch.

*Historiese en argitektoniese belang*

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Teunis Nicolaas Hendrik Janson, Minister van Nasionale Opvoeding, hierby die eiendomme met die twee Indiërwinkelgeboue daarop, in Retiefstraat, Weenen, tot nasionale gedenkwaardigheid.

*Description*

The old Law Court building, situated on the following lots:

(a) Lot 46 situate on the Bay Foreshore and being the frontage of Remainder of Lot 3, Block A, of the Town Lands of Durban, Natal.

Deed of Transfer 600/1903, dated 12 March 1903.

(b) Lot 45 of Block A on the Bay Foreshore of the Town Lands of the Municipality of Durban, Province of Natal.

Deed of Transfer 3376/1921, dated 6 September 1921, (paragraph 2).

*Historical and architectural interest*

This building, designed by the architect Stanley Hudson, was erected in 1911. 10/2/797.

DECLARATION OF THE JEWISH SKUINSHUIS AND CHICKEN-COOP, SITUATED AT 44 VAN RYNEVELD STREET, STELLENBOSCH

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the so-called Jewish Skuinshuis, situated at 44 Van Ryneveld Street, Stellenbosch, together with a surrounding area which includes the historic chicken-coop, as described more fully below, to be a national monument.

*Description*

The property with the Jewish Skuinshuis and chicken-coop thereon, as shown by the architect G. T. Fagan as the figure ABCDEFGHIJA on Diagram 7405/1, filed in the offices of the Registrar of Deeds and the National Monuments Council in Cape Town, situate on certain piece of land in the Municipality and Division of Stellenbosch, being Erf 4296, Stellenbosch.

Deed of Transfer 35695/1970, dated 8 December 1970.

*Historical and architectural interest*

The core of this double-storeyed building dates from about 1782. The facade of the house was rebuilt during the first half of the nineteenth century. The building, together with the historic chicken-coop, forms a unique architectural complex. 10/2/792.

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the properties with the two Indian shop buildings thereon, in Retief Street, Weenen, to be a national monument.

*Beskrywing*

Die eiendomme met die twee winkelgeboue daarop, te wete:

(a) Onderverdeling A van Perseel 102 (nou bekend as Onderverdeling 1 van Perseel 66) in die dorp Weenen, provinsie Natal, en groot 3 546 vierkante meter.

(b) Onderverdeling B van Perseel 66 (nou bekend as Onderverdeling 2 van Perseel 66), geleë in die dorp Weenen, county Weenen, provinsie Natal, en groot 1 773 vierkante meter.

*Historiese en argitektoniese belang*

*Historiese en wetenskaplike belang*

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Teunis Nicolaas Hendrik Janson, Minister van Nasionale Opvoeding, hierby die eiendom met die historiese Vrouemonument daarop, te Bloemfontein, tot nasionale gedenkwaardigheid.

*Description*

The properties with the two shop buildings thereon, namely:

(a) Subdivision A of Lot 102 (now known as Subdivision 1 of Lot 66) in the Township of Weenen, Province of Natal, and measuring 3 546 square metres.

Deed of Transfer 314/1931, dated 29 January 1931; and

(b) Subdivision B of Lot 66 (now known as Subdivision 2 of Lot 66) in the Township of Weenen, County of Weenen, Province of Natal, and measuring 1 773 square metres.

Deed of Transfer 4743/1952, dated 16 June 1952 (paragraaf 2).

*Historical and architectural interest*

These two typical Indian shops date from the beginning of the twentieth century and from an impressive architectural entity. 10/2/794.

DECLARATION OF THE PROPERTY WITH THE GEOLOGICAL EXPOSURE THEREON, IN CORINTHIA ROAD, DURBAN

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Teunis Nicolaas Hendrik Janson, Minister of National Education, hereby declare the property with the geological exposure thereon, in Corinthia Road, Reedbank, Durban, to be a national monument.

*Description*

The property with the geological exposure thereon, being the remainder of a certain piece of land called Lot 56 of Reedbank of the farm Springfield 802, situate in the City of Durban, Province of Natal, and measuring 9 295 square feet.

Deed of Transfer 4781/1940, dated 2 October 1940.

*Historical and scientific interest*

The glaciated pavement shows striae on Table Mountain sandstone at the base of the Dwyka tillite of the Karoo System and is approximately 300 million years old. 10/2/791.
