Hierdie kantoorgebou, wat vroeg in 1887 vir Sammy Marks voltooi is, dateer uit Barberton se bloeitydperk en is 'n belangrike skakel met ou Barberton. Dit is vermoedelik die oudste bestaande meerverdiepinggebou in Transvaal. 10/2/817.

The E.T.C. Building, situated on the property known as Certain Stand 1508, situate on Pilgrim Street in the Township of Barberton, District of Barberton, measuring seventeen (17) square roods fifty-two (52) square feet.

Historical and architectural interest

This office building, which was completed for Sammy Marks early in 1887, dates from Barberton's boom period and is an important link with old Barberton. It is thought to be the oldest existing multi-storey building in the Transvaal. 10/2/817.

Beskrywing

Die Veldtuin, bestaande uit die volgende eiendomme:

(a) Sekere Perseel 2333 (synde 'n gedeelte van die resterende gedeelte van Reserwe 2) (nou bekend as Gedeelte 15 van Erf 2389), geleë aan St. Patricksweg en Houghtonrylaan, van die gedeelte bekend as Houghton Estate Township van die plaas Houghton Estate 5, distrik Johannesburg, groot nege (9) morg vierhonderd sewe-en-dertig (437) vierkante roede vier-en-tagtig (84) vierkante voet.

Transportakte F1305/1925, gedateer 15 April 1925 (paragraaf 1).

(b) Sekere resterende gedeelte van Reserwe 1 (nou bekend as resterende gedeelte van Erf 2388), geleë aan Houghtonrylaan op die gedeelte bekend as Houghton Estate Township van die plaas Houghton Estate 5, distrik Johannesburg, groot nege (9) morg vierhonderd twee-en-twintig (422) vierkante roede sewentien (17) vierkante voet.

DECLARATION OF THE WILDS IN HOUGHTON
ESTATE, JOHANNESBURG

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare The Wilds in Houghton Estate, Johannesburg, comprising the properties as described below, to be a national monument.

Description

The Wilds, comprising the following properties:

(a) Certain Lot 2333 (being a portion of the remaining extent of Reserve 2) (now known as Portion 15 of Erf 2389), situate on St Patrick's Road and Houghton Drive, of that portion known as Houghton Estate Township of the farm Houghton Estate 5, District of Johannesburg, measuring nine (9) morgen four hundred and thirty-seven (437) square roods eighty-four (84) square feet.

Deed of Transfer F1305/1925, dated 15 April 1925 (paragraph 1).

(b) Certain remaining extent of Reserve 1 (now known as remaining extent of Erf 2388), situate on Houghton Drive on that portion known as Houghton Estate Township of the farm Houghton Estate 5, District of Johannesburg, measuring nine (9) morgen four hundred and twenty-two (422) square roods seventeen (17) square feet.

Deed of Transfer F1305/1925, dated 15 April 1925 (paragraph 2).

(c) Remaining extent of certain freehold lot marked 2300, situate on Munro and Houghton Drives, measuring four hundred and eighty-four (484) square roods one hundred and eight (108) square feet, situate on that portion known as Houghton Estate Township of the freehold farm Houghton Estate 5, District of Johannesburg.

Deed of Transfer F1440/1938, dated 23 February 1938.

Historiese en estetiese belang

In 1925 het die Johannesburg Consolidated Investment Company Ltd. die oorspronklike gedeelte van Die Veldtuin aan die Johannesburgse Munisipaliteit geskenk op voorwaarde dat dit as oop ruimte vir die ontspanning van die publiek behou word. Sedert 1936 is Die Veldtuin slegs met inheemse flora beplant en het dit ontwikkel tot wat waarskynlik die aantreklikste park in Johannesburg is. 10/2/820.

Wapen.—Gevierendeel van blou en silwer, 'n skyf gegeer van twaalf, rooi en goud, gesoom van 'n ring, gevierendeel van blou en silwer met twaalf uitkomende driehoekige strale om die beurt goud en rooi, die geheel binne-in 'n ring van die een in die ander.

Historical and aesthetic interest

In 1925 the Johannesburg Consolidated Investment Company Ltd donated the original portion of The Wilds to the Municipal Council of Johannesburg, on condition that it be kept as an open space for the recreation of the public. Since 1936 The Wilds has been planted with indigenous flora only and has developed into what is probably the most attractive park in Johannesburg. 10/2/820.

The façade of the Victorian semi-detached cottage, situated on certain piece of land in the Municipality and Division of Stellenbosch, being Erf 2108, Stellenbosch.

Deed of Transfer 21584/1980, dated 30 June 1980.

Historical and architectural interest

This Victorian cottage forms part of a row of five semi-detached cottages that date from the late nineteenth century. 10/2/821.
