DECLARATION OF THE PROPERTY, TOGETHER WITH THE LUTHERAN CHURCH BUILDING, THE PARSONAGE AND THE SCHOOL BUILDING THEREON, AT BRAUNSCHWEIG, DISTRICT OF KING WILLIAM'S TOWN

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the property, together with the Lutheran Church building, the parsonage and the school building thereon, at Braunschweig, District of King William's Town, to be a national monument.

Description

The property, together with the Lutheran Church building, the parsonage and the school building thereon, situate on the following erven:

(a) A piece of land, being Lots 1, 2, 7 and 8, Blok P, situate in the Village of Braunschweig, Division of King William's Town (now known as Erf 544, Braunschweig), and measuring 170,08 square roods.

Deed of Grant 289/1868, dated 26 May 1868 (endorsement p. 2); and

(b) certain piece of freehold land, being Lot 3, Blok P, situated in the Village of Braunschweig, in the Division of King William's Town (now known as Erf 545, Braunschweig), and measuring 607 square metres.

Deed of Transport 1010/1904, dated 9 September 1904 (endorsement p. 5).

Historical and architectural interest

This Lutheran Church complex consisting of the neo-Gothic church building of 1904, the parsonage of 1860 and the school building of 1860 and extension of 1904, is closely associated with the arrival of the German Legion in 1857 and thereafter the German Settlers in South Africa. 10/2/852.

DECLARATION OF THE SO-CALLED HILLDROP HOUSE (ALSO KNOWN AS SIR RIDER HAGGARD'S HOUSE), AT NEWCASTLE

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the so-called Hilldrop House (also known as Sir Rider Haggard's house) and the land on which it stands, at Newcastle, to be a national monument.

Description

The so-called Hilldrop House and the land on which it stands, situate on Subdivision 36 (a subdivision of 1) of the farm Bosch Hoek 3345, in the County of Klip River, Province of Natal, and measuring twenty comma two three four three (20,2343) hectares.

(a) 'n Stuk grond, synde Persele 1, 2, 7 en 8, Blok P, geleë in die dorp Braunschweig, afdeling King William's Town (nou bekend as Erf 544 Braunschweig) en groot 170,08 vierkante roede.

(b) 'n sekere stuk eiendomsgrond, synde Perseel 3, Blok P, geleë in die dorp Braunschweig, in die afdeling King William's Town (nou bekend as Erf 545, Braunschweig) en groot 607 vierkante meter.

Historiese en argitektoniese belang

Hierdie Lutherse Kerkkompleks bestaande uit die neo-Gotiese kerkgebou van 1904, die pastorie van 1860 en die skoolgebou van 1860 en aanbouing van 1904, was ten nouste verbonde met die aankoms van die Duitse Legioen in 1857 en daarna die Duitse Setlaars in Suid-Afrika. 10/2/852.

Beskrywing

Die sogenaamde Hilldrop House en die grond waarop dit staan, geleë op Onderverdeling 36 ('n onderverdeling van 1) van die plaas Bosch Hoek 3345 geleë in die county Kliprivier, provinsie Natal, en groot twintig komma twee drie vier drie (20,2343) hektaar.

Transportakte 16332/1980, gedateer 11 Julie 1980.

Historical and architectural interest

This imposing building was erected by Sir Melmoth Osborne, resident magistrate of Newcastle from 1868 to 1875. Sir Rider Haggard took occupation in January 1881 and during his sojourn the Royal Commission which drew up the terms of the Pretoria Convention and which provided for the retrocession of the Transvaal after the First Anglo-Boer War, 1880-1881, held its meeting here.

Present on this occasion were Sir Hercules Robinson, Sir Henry de Villiers, President Brand and Sir Evelyn Wood. 10/2/858.

RESTRICTION OF ACCESS TO THE SA ARMY BATTLE SCHOOL TRAINING AREA

Hierdie imposante gebou is opgerig deur sir Melmoth Osborne, resident-magistraat van Newcastle van 1868 tot 1875. Sir Rider Haggard het dit in Januarie 1881 betrek en gedurende sy verblyf het die Koninklike Kommissie wat die bepalings van die Konvensie van Pretoria opgestel het, waarin voorsiening gemaak is vir die teruggawe van Transvaal na die Eerste Vryheidsoorlog, 1880-1881 sy vergadering hier gehou.
