DECLARATION OF THE PROPERTY, TOGETHER WITH THE SO-CALLED RYLEY'S HOUSE, AS WELL AS THE OUTBUILDINGS THEREON, SITUATE AT 79 KAREL LANDMAN STREET, DUNDEE

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the property, together with the so-called Ryley's House, as well as the outbuildings thereon, situate at 79 Karel Landman Street, Dundee, to be a national monument.

Description

The property, together with the buildings thereon, situate on Remainder of Lot 1 of the Townlands of the Government Extension of Dundee Proper, situate in the Borough of Dundee, County of Klip River, Province of Natal (now known as Lot 1496, Dundee), and measuring 37 716 hectares.

Historical and architectural interest

This Victorian building complex dates from the years 1902-1903 and is an excellent example of Natal Colonial architecture from that period. 10/2/861.

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the 23 properties as more fully described hereunder, together with the buildings thereon, situated in the historic Old Wynberg Village, Wynberg, Cape Town, to be national monuments.

Description
