

*Description*

The historical Principal's Residence, previously known as the Officers' Mess, situate on the Remainder of Erf 511, in the Municipality and Division of King William's Town, Province of the Cape of Good Hope.

Certificate of Registered State Title 554/1962, dated 3 July 1962 (Paragraph 1).

*Historical and architectural interest*

This U-shaped building was erected largely in 1849 as an Officers' Mess at a time when King William's Town formed the centre of the Frontier Wars and accommodated a large garrison. The building was used as a mess until 1884, after which it served, *inter alia*, as a dwelling for the Paymaster, the Inspector General and a Military Chaplain. 10/2/992.

DECLARATION OF THE HISTORIC BUILDING  
KNOWN AS THE CARNARVON MASONIC LODGE,  
IN RUSSEL STREET, RICHMOND, NATAL

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the historical building known as the Carnarvon Masonic Lodge, situate in Russel Street, Richmond, Natal, to be a national monument.

*Description*

The historical building known as the Carnarvon Masonic Lodge, situate on certain piece of land, being Lot 8, Block C (now known as Lot 272, Richmond Township), in the Village of Richmond, Municipality of Richmond, Natal.

Deed of Transfer 262/1882, dated 22 March 1882.

*Historical and architectural interest*

This rectangular brick building with its Victorian embellishments was erected in 1883 to accommodate the local Freemasons' Lodge. This Lodge was established in 1876 and named after the fourth Earl of Carnarvon. 10/2/991.
