

WAR GRAVES AND NATIONAL MONUMENTS ACT,  
No. 28 OF 1969

DECLARATION OF THE FAÇADES OF THIRTY-THREE (33) HOUSES IN THE HISTORICAL CORE OF GRAAFF-REINET, TEN (10) SITUATED IN BOURKE STREET, TWENTY-TWO (22) IN SOMERSET STREET AND ONE (1) IN PARSONAGE STREET.

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the façades of thirty-three (33) houses in the historical core of Graaff-Reinet, ten (10) situated in Bourke Street, twenty-two (22) in Somerset Street and one (1) in Parsonage Street, as more fully described below, to be national monuments.

*Description*

The façades of thirty-three (33) houses as situated on the undermentioned properties:

(1) *2 Bourke Street, Graaff-Reinet:*

Certain piece of land, being the Remainder of Erf 207, Graaff-Reinet, situate in the Municipality and Division of Graaff-Reinet.

Deed of Transfer 31599/1980, dated 28 August 1980.

(2) *4 Bourke Street, Graaff-Reinet:*

Certain piece of land, being Erf 208, Graaff-Reinet, situate in the Municipality and Division of Graaff-Reinet.

Deed of Transfer 21566/1972, dated 5 September 1972.

(3) *7 Bourke Street, Graaff-Reinet:*

(i) Certain piece of land, being Erf 1294, Graaff-Reinet, situate in the Municipality and Division of Graaff-Reinet; and

(ii) certain piece of land, being Erf 1295, Graaff-Reinet, situate as above.

Deed of Transfer 26335/1973, dated 14 September 1973.

(4) *24 Bourke Street, Graaff-Reinet:*

Certain piece of land, being Erf 220, Graaff-Reinet, situate in the Municipality and Division of Graaff-Reinet.

Deed of Transfer 31462/1972, dated 7 December 1972.

(5) *26 Bourke Street, Graaff-Reinet:*

Certain piece of land, being the Remainder of Erf 222, Graaff-Reinet, situate in the Municipality and Division of Graaff-Reinet.

Deed of Transfer 24890/1972, dated 6 October 1972.

(6) *46 Bourke Street, Graaff-Reinet:*

Certain piece of land, being the Remainder of Erf 599, Graaff-Reinet, situate in the Municipality and division of Graaff-Reinet.

Deed of Transfer 13169/1981, dated 24 March 1981 (paragraph 2).
