In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the William Fehr Collection, as more fully described in the schedule hereto, to be a national cultural treasure because of its historical and cultural importance.

**Description**

The entire William Fehr Collection, consisting of furniture, ceramics, glass, silver, brass, wood, oil and water-colour paintings and drawings, as well as intaglio, relief and lithographic prints, photographs, plans and maps from the 17th (seventeenth) to the 19th (nineteenth) century, and housed at Castle Good Hope and at Rust en Vreugd in Buitenkant Street, Cape Town.
