

3. DIE EIENDOM BEKEND AS *FANCOURT*, IN MONTAGUWEG, BLANCO, GEORGE

Beskrywing

5. DIE KORBEELHUIS-KOMPLEKS GELEË OP DIE PLAAS T'KOKOBOOS 500, IN DIE DISTRIK CARNARVON

6. DIE EIENDOM MET DIE *COOWATool ISLAM-MOSKEE* DAAROP, IN LOOPSTRAAT, KAAPSTAD

Beskrywing

Die eiendom, tesame met die *Coowatool Islam-moskee* daarop, synde sekere stuk grond gemerk Persele 1, 2 en 3, Kaapstad (nou bekend as Erf 3186, Kaapstad), geleë in die stad en munisipaliteit Kaapstad, en groot 391 (driehonderd een-en-negentig) vierkante meter.

5. THE CORBELLED HOUSE COMPLEX, ON THE FARM T'KOKOBOOS 500, IN THE DISTRICT OF CARNARVON

The corbelled house complex, together with ten metres of surrounding land, situated on Portion 2 ('Tkokoboos) of the farm T'Kokoboos 500, in the Division of Carnarvon.

6. THE PROPERTY WITH THE *COOWATool ISLAM MOSQUE* THEREON, IN LOOP STREET, CAPE TOWN

The property, together with the *Coowatool Islam Mosque* thereon, being certain piece of land marked Lots 1, 2 and 3, Cape Town (now known as Erf 3186, Cape Town), situated in the City and Municipality of Cape Town, in extent 391 (three hundred and ninety-one) square metres.
