- 1. THE SITE WITH THE HISTORICAL BUILDINGS THEREON, SITUATED IN THE ELIM HOSPITAL COMPLEX NEAR LOUIS TRICHARDT, IN THE SOUTPANSBERG DISTRICT**

*Description*

The main building complex of the Elim Hospital, including the 1912 addition, the doctor's house and the Old Indian Ward, together with a portion of surrounding land, being that portion defined by a line starting at the north-easterly corner of the Old Indian Ward; thence seven metres in a northerly direction; thence fifteen metres in a westerly direction; thence sixty-one metres in a northerly direction; thence sixty-eight metres in a westerly direction; thence fifty-three metres in a southerly direction; thence twelve metres in a westerly direction; thence forty-seven metres in a southerly direction; thence ninety-five metres in an easterly direction and thence thirty-two metres in a northerly direction to the starting point, as well as the chapel together with the eight metres of surrounding land, all situated on the Remainder of the farm Waterval 45, Registration Division LT, Transvaal (now Northern Province).
