DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the City Hall in Port Elizabeth to be a national monument.

Description

The City Hall, situated on Erf 1793, Port Elizabeth Central, in the Municipality and Administrative District of Port Elizabeth and measuring 75 square roods, held under Port Elizabeth Freeholds Volume I (Part II) Folio 64, dated 8 June 1859.

Historical and Architectural Interest

This impressive City Hall was completed in about 1862, although the clock tower was added later. The neoclassical style of this building impressed numerous travellers and writers in the 19th century and is today still regarded as one of the most imposing buildings of its kind in South Africa.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Johannes Petrus van der Spuy, Minister van Nasionale Opvoeding, hierby die Stadsaal in Port Elizabeth tot nasionale gedenkwaardigheid.

Beskrywing

Die Stadsaal, geleë op Erf 1793, Port Elizabeth-Sentraal, in die munisipaliteit en administratiewe distrik Port Elizabeth en groot 75 vierkante roede, gehou kragtens Port Elizabeth-vrypakte Volume 1 (Deel II) Folio 64, gedateer 8 Junie 1859.

Historiese en Argitektoniese Belange

Hierdie indrukwekkende Stadsaal is teen 1862 voltooi, hoewel die kloktoring eers later aangebring is. Die neoklassieke styl van hierdie gebou het talle reisigers en skrywers in die 19de eeu geïmponeer en dit word vandag nog as een van die mees imposante geboue in sy soort in Suid-Afrika beskou.
