
1. THE PROPERTY, TOGETHER WITH THE SO-CALLED FRERE MASONIC LODGE AND HALL THEREON, SITUATED AT 10 LONG STREET, RIVERSDALE

Description:

The property, together with the so-called Frere Masonic Lodge and Hall thereon, is described as follows:
