NATIONAL MONUMENTS ACT, No. 28 OF 1969

ENTRIES IN THE REGISTER OF IMMOVABLE CONSERVATION-WORTHY PROPERTY

In terms of section 51 (1) (cC) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby enters in the official register the immovable property as fully described in the Schedule hereto and which the Council regards as worthy of conservation on account of its historical, cultural or aesthetic interest.

1. The historical farmstead, situated on the farm Sun Gabriel 583, District of Somerset West.
2. The property with the historical building thereon, being Erf 3363, Onrus River, situated at 8 De Villiers Street, Onrus River, District of Hermanus.
3. The school building, situated on Erven 20182, 20183, 20184, 20185 and 22071, East London, at Hood Street, East London.
4. The St Lucia lighthouse, situated on Subdivision 1 of the farm Reserve 415823, District of Lower Umfolozi.
5. The building known as the Ramblers Club, situated on Erf 1930, Bloemfontein, at Aliwal Street, Bloemfontein
6. The St Bartholomew Anglican church building, situated on Erf 16, Dewetsdorp, at 27 Van der Wath Street, Dewetsdorp.
7. The historical farmstead, situated on the farm Buffelsdoorn 143 IQ, District of Potchefstroom.
8. The property with the historical dwelling thereon, being Erf 1051, Ficksburg, situated at 81 McCabe Street, Ficksburg.

INSKRYWINGS IN DIE REGISTER VAN ONROERENDE BEWARENSWAARDIGE GOED

4. Die St Lucia-vuurtoring, geleë op Onderverdeling 1 van die plaas Reserve 415823, distrik Laer Umfolozi.
5. Die gebou bekend as die Ramblers-klub, geleë op Erf 1930, Bloemfontein, te Aliwalstraat, Bloemfontein.
6. Die St Bartholomew Anglikaanse kerkgebou, geleë op Erf 16, Dewetsdorp, te Van der Wathstraat 27, Dewetsdorp.
7. Die historiese plaasopstal, geleë op die plaas Buffelsdoorn 143 IQ, distrik Potchefstroom.
8. Die eiendom met die historiese woning daarop, synde Erf 1051, Ficksburg, geleë te MacCabestraat 81, Ficksburg.
