

### PROCLAMATION OF ANTIQUES AND CANCELLA- TION OF GOVERNMENT NOTICE.

I. By virtue of the powers vested in me by paragraph (c) of sub-section (1) of section *eight* of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), as amended, I proclaim the "Simon Pieter Christoffel Londt Pulpit and Lectern" to be antiques.

#### Description.

A pulpit and lectern in the Rhenish Church, situate on Erven Nos. 668 and 669, in the Municipality and Division of Stellenbosch, Province of the Cape of Good Hope.

#### Historical Interest.

The pulpit and lectern were made by Simon Pieter Christoffel Londt in 1853.
