**DECLARATION OF A NATIONAL MONUMENT**

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare Erf 6144, with the historic buildings thereon, situate at 9, 11 and 13 Market Street, Stellenbosch, to be a national monument.

*Description*

Certain piece of land, partly freehold land, being Erf 6144, Stellenbosch, with the historic buildings thereon, known as 9, 11 and 13 Market Street, situate in the Municipality and Division of Stellenbosch, and measuring as such four thousand six hundred and ninety-four (4 694) square metres.
