HISTORIESE BELANG.

Hierdie eenvoudige grasdakhuisie is tipies van die boukuns uit die Transvaalse pionierstyd van 'n eeu gelede. Dit is waarskynlik die oudste skoolgebou in Transvaal.

BESKRYWING.

Die Burgerhuis, Stellenbosch: Die figuur A.B.C.D.E.F. stel voor Erf No. 3389, gedeelte van Erf No. 613, Stellenbosch, geleë in die munisipaliteit en afdeling Stellenbosch, provinsie Kaap die Goeie Hoop, soos aangedui op Kaart No. 300/60, aangeheg aan Grondbrief No. 206/60, gedateer 17 November 1960, ten gunste van die Munisipaliteit van Stellenbosch.

HISTORIESE BELANG.

Hierdie huis is 'n besondere mooi voorbeeld van die Ou Kaaps-Hollandse boustyl. Dit is in 1797 opgerig en die bouer was Antonie Fick, waarskynlik in samewerking met die beroemde Anreith en Thibault.

Clause 15.—Delete sub-clauses (1) and (2) of clause 15 and substitute the following sub-clauses (1) and (2):—

DESCRIPTION.

Old school building, Lydenburg: The old school building situate on portion of Portion A of Erf No. 25, at the corner of Kerk and Kantoor Streets, township of Lydenburg, Province of the Transvaal.

HISTORICAL INTEREST.

This simple thatched house is typical of the architecture of the pioneer times in the Transvaal of a century ago. It is probably the oldest school building in the Transvaal.

PROCLAMATION OF A MONUMENT.

By virtue of the powers vested in me by sub-section (1) of section *eight* of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), as amended, I hereby proclaim The Burgher House, Stellenbosch, to be a monument.

DESCRIPTION.

The Burgher House, Stellenbosch: The figure A.B.C.D.E.F. represents Erf No. 3389, portion of Erf No. 613, Stellenbosch, situate in the Municipality and Division of Stellenbosch, Province of the Cape of Good Hope, as shown on Diagram No. 300/60, attached to Title Deed No. 206/60, dated 17th November, 1960, in favour of the Municipality of Stellenbosch.

HISTORICAL INTEREST.

This house is an exceptionally fine example of Old Cape Dutch architecture. It was erected in 1797 and the builder was Antonie Fick, probably in collaboration with the famous Anreith and Thibault.
