

**3. THE RUIN OF THE ANGLO-BOER WAR FORT KNOWN AS THOMSON'S FOLLY, KNYSNA***Description*

9/2/052/30

The ruin of the fort known as Thomson's Folly dating from the Anglo-Boer War (1899-1902), together with a surrounding area of fifteen (15) metres, situated on Erf 1364, Knysna.

**4. ROSE COTTAGE CAVE, IN THE LADYBRAND DISTRICT***Description*

The Rose Cottage Cave, situated on a portion of the Remainder of the farm Ladybrand Townlands 451, in the Ladybrand District, in extent 1,8643 (one comma eight six four three) hectares, as indicated by the figure A B C D on Surveyor's Diagram SG209/1998, dated 31 March 1998, and filed in the office of the Surveyor General in Bloemfontein and on file 9/2/325/6, in the office of the National Monuments Council in Cape Town.

**5. THE PROPERTY WITH THE OLD SYNAGOGUE THEREON, IN PAUL KRUGER STREET, PRETORIA***Description*

The property with the Old Synagogue thereon, being Erven 103 and 104, in the City of Pretoria, Gauteng, in extent 2 552 (two five five two) and 1 243 (one two four three) square metres respectively.

**6. THE OLD G.A. ZAHN CHURCH-AND-SCHOOL BUILDING IN STEINTHAL, TULBAGH DISTRICT***Description*

The Old G.A. Zahn church-and-school building in Steintal, together with ten (10) metres of surrounding land, situated on the Remaining Extent of the farm Witzenberg 182, in the Tulbagh District.

**7. THE OLD BERLIN MISSION COMPLEX, DU PLOOY STREET, POTCHEFSTROOM***Description*

The property with the Old Berlin Mission complex thereon, including the church building, the parsonage, the school building and the carriage-house, situated on the Remainder of Portion 2 of Erf 219, Potchefstroom, Registration Division IQ, North West Province, in extent 1 406 (one thousand four hundred and six) square metres.

**8. THE FORMER HOUSE OF PRESIDENT MANDELA, NOW KNOWN AS "MANDELA HOUSE", IN NGAKANE STREET, ORLANDO WEST, SOWETO***Description*

The property together with the former house of President Mandela, now known as "Mandela House", being Erf 8115, Orlando West Township, Registration Division IQ, Gauteng, in extent 394 (three hundred and ninety-four) square metres.

**9. THE CRADOCK PASS OVER THE OUTENIQUA MOUNTAINS, GEORGE DISTRICT***Description*

9/2/030/23

The Cradock Pass over the Outeniqua Mountains, together with a portion of land described as the area beginning at point A, being the confluence of the Keur River and the Tierkloof River where the Malgas River is formed; thence in a north-easterly direction to point B where the railway line crosses the Tierkloof River; thence in a north-easterly direction to point B where the railway line crosses the Tierkloof River; thence in a north-north-easterly direction to point C, being spot height 1 372 m; thence in a north-north-westerly direction to point D, being the southernmost boundary beacon of farm 129/1 and the most westerly boundary beacon of farm 129; thence to point E, being the most South-westerly boundary beacon of farm 129/1; thence in a southerly direction to point F atop spot height 1 065 m; thence in a south-westerly direction to point G at the Keur River Bridge; thence in a southerly direction to point H, being the Motagu toll-house; thence in a south-easterly direction to the starting point, all situated on the following farms:
