

6. THE PROPERTY WITH THE HISTORIC HOUSE KNOWN AS *RHEEZICHT* THEREON, INCLUDING THE GATES AND RING-WALL, AT GORGE ROAD, ORANJEZICHT, CAPE TOWN

Description

The property with the historic house known as *Rheezicht* thereon, including the gates and the ring-wall, being Erf 3101, Oranjezicht, in the Municipality of Cape Town, Administrative District of the Cape, in extent 5 841 (five thousand eight hundred and forty-one) square metres.

The original *Houses of Parliament* as they existed before the extension of 1988, including the garden on the northern side stretching to Parliament Lane, situated on a portion of unregistered State land, now known as Erf 95165, Cape Town, in the Municipality of Cape Town.
