6. THE HISTORIC NZASM RAILWAY BRIDGE OVER THE KOMATI RIVER, NEAR KOMATIPOORT, IN THE DISTRICT OF BARBERTON

Description

The two abutments and six piers of the historic NZASM railway bridge, together with five metres of surrounding land, situated on portions of the following properties:

(i) The Komatipoort Station Railway Reserve 161, situated in Registration Division JU, in the District of Barberton.

(ii) Portion 6, named Janalet, of the farm Lebombo 186, situated in Registration Division JU, Transvaal.

7. THE PORTION OF LAND ZONED AS A PUBLIC OPEN SPACE BETWEEN NETTLETON ROAD AND THE SEA, BETWEEN BANTRY BAY AND CLIFTON, AT CAPE TOWN

Description

The portion of land zoned as a Public Open Space between Nettleton Road and the sea, between Bantry Bay and Clifton, described as the area starting at the westernmost beacon of Erf 53, Bantry Bay (Diagram 4789/1937); thence in a general southerly direction along the boundaries of the following properties so as to include them in the area: Erf 50, Bantry Bay (Diagram No. 1399/1901); Erf 52, Bantry Bay (Diagram 2906/1924); the said Erf 50 to the southernmost beacon thereof; thence in a south-easterly direction across Victoria and Kloof Roads to the westernmost beacon of Erf 28, Bantry Bay (Diagram A.2427/1925); thence in a straight line across Erf 148, Clifton (filed as Plan 146) to the northernmost beacon of Erf 133, Clifton (Diagram A.1425/1931); thence in a south-westerly direction in a straight line across Kloof and Victoria Roads to the north-west beacon of Erf 269, Clifton (Diagram 4131/1962); thence in a south-westerly direction along the elongation of the said straight line to a point where it intersects the low-water mark; thence in a general northerly direction along the said low-water mark to a point being the intersection of the projected line true north of the westernmost beacon of Erf 53, Bantry Bay; thence southwards along the said projected line across Erf 80, Bantry Bay (Diagram 2750/1919) to the beacon first named.

7. DIE GEDEELTE GROND GESONEER AS 'N OPENBARE OOP RUIMTE TUSSEN NETTLETONWEG EN DIE SEE, TUSSEN BANTRYBAAI EN CLIFTON, TE KAAPSTAD

Beskrywing

Die gedeelte grond gesoneer as 'n Openbare Oop Ruimte tussen Nettletonweg en die see, tussen Bantrybaai en Clifton, beskryf as die gebied beginnende by die westelikste baken van Erf 53, Bantrybaai (Diagram 4789/1937); daarvandaan in 'n algemene suidelike rigting met die grense van die volgende eiendomme langs sodat die eiendomme by die gebied ingesluit word: Erf 50, Bantrybaai (Diagram 1399/1901); Erf 52, Bantrybaai (Diagram 2906/1924); genoemde Erf 50 tot by die suidelikste baken daarvan; daarvandaan in 'n suidoostelike rigting oor Victoria- en Kloofweg tot by die westelikste baken van Erf 28, Bantrybaai (Diagram A.2427/1925); daarvandaan in 'n reguit lyn oor Erf 148, Clifton (geliasseer as Plan 146) tot by die noordelikste baken van Erf 133, Clifton (Diagram A.1425/1931); daarvandaan in 'n suidwestelike rigting in 'n reguit lyn oor Kloof- en Victoriaweg tot by die noordwestelike baken van Erf 269, Clifton (Diagram 4131/1962); daarvandaan in 'n suidwestelike rigting met die verlenging van genoemde reguit lyn langs tot by 'n punt waar dit die laagwatermerk kruis; daarvandaan in 'n algemene noordelike rigting met genoemde laagwatermerk langs tot by 'n punt synde die kruising van die voorgenoemde lyn ware noord van die westelikste baken van Erf 53, Bantrybaai; daarvandaan suidwaarts met die voorgenome lyn oor Erf 80, Bantrybaai (Diagram 2750/1919) langs, tot by eersgenoemde baken.
