WAR GRAVES AND NATIONAL MONUMENTS ACT,
No. 28 OF 1969
DECLARATION OF ERVEN 1364 AND 1365, SITUATED AT 18 BOWNESS STREET, BARBERTON

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Pierre Cronjé, Deputy Minister of National Education, hereby declare the properties known as Erven 1364 and 1365, Barberton, as described below, with the dwelling-house situated at 18 Bowness Street and all other improvements thereon, to be a national monument.

Description

(a) The property known as Erf 1364, with all the improvements thereon, situate in the Township of Barberton, Registration Division JU, Transvaal, in extent 991 (nine hundred and ninety-one) square metres.

(b) The property known as Erf 1365, with all the improvements thereon, situate in the Township of Barberton, Registration Division JU, Transvaal, in extent 991 (nine hundred and ninety-one) square metres.

Historical and architectural interest

This well-preserved dwelling-house and outbuildings of wood and iron were erected by J. S. Stopforth during the eighties of the previous century. The building complex has remained unaltered and it therefore provides an important cultural-history link with old Barberton. (RNG 10/2/1008.)

Historiese en argitektoniese belang

Hierdie goedbewaarde woonhuis en buitegeboue van hout en yster is gedurende die tagtigerjare van die vorige eeu deur J. S. Stopforth opgerig. Die gebouekompleks het onveranderd behoue gebly en is dus 'n belangrike kultuur-historiese skakel met ou-Barberton. (RNG 10/2/1008.)
