DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Johannes Petrus van der Spuy, Minister of National Education, hereby declare the church, known as St Michael and All Angels, Boksburg, to be a national monument.

*Description*

The church, known as St Michael and All Angels, situate on Erven 253, 254, 255 and 256 in Boksburg in the Division of the Transvaal, and measuring as such 1 486 square metres.

Deed of Transfer F3568/25 of 9 October 1925 (Erven 255 and 256) Deed of Reserve 1/25 of 25 August 1925 (Erven 253 and 254).

*Historical Interest*

The Church of St Michael and All Angels was designed by Sir Herbert Baker in the Romanesque style and consecrated in 1912.

DECLARATION OF A NATIONAL MONUMENT

*Description*

The historic Church Square in Worcester, being an unregistered piece of land which has not been subdivided, and being bounded by High Street, Church Street, Baring Street and Adderley Street.

*Historical Interest*

Church Square forms an integral part of the original town plan of Worcester as it was drawn up in 1819. In former times the Square was often used for open-air
