

3. RUIMZICHT-HUIS, TAMBOERSKLOOF, KAAPSTAD

*Beskrywing:*

Die eiendom met die sogenaamde Ruimzicht-huis daarop, synde Erf 999, Tamboerskloof, geleë in die stad Kaapstad, Kaapse Afdeling, en groot 608 (seshonderd-en-agt) vierkante meter.

4. FULHAMWEG 143, BRIXTON, JOHANNESBURG

*Beskrywing:*

Die eiendom bekend as Erf 85, insluitende die huis en alle verbeterings daarop, geleë in die dorpsgebied Brixton, Registrasie-afdeling IR, Transvaal, en groot 469 (vierhonderd nege-en-sestig) vierkante meter.

9. KAAPS-HOLLANDSE WOONHUIS, PRINS ALBERT

*Beskrywing:*

3. THE RUIMZICHT HOUSE, TAMBOERSKLOOF, CAPE TOWN

*Description:*

The property with with the so-called Ruimzicht House thereon, being Erf 999, Tamboerskloof, situate in the City of Cape Town, Cape Division, in extent 608 (six hundred and eight) square metres.

Deed of Transfer 50051/1984, dated 5 October 1984.

4. FULHAM ROAD 143, BRIXTON, JOHANNESBURG

*Description:*

The property known as Erf 85, including the house and all other improvements thereon, situate in Brixton Township, Registration Division IR, Transvaal, in extent 469 (four hundred and sixty-nine) square metres.

5. GREYSTONES, ST JAMES, CAPE TOWN

7. THE HISTORIC TREE-GARDEN, BLOEMFONTEIN

*Description:*

The historic tree-garden in front of the Nasionale Afrikaanse Letterkundige Museum en Navorsingsentrum (formerly the Government Building), situate on a portion of a certain piece of land (now known as Erf 1928) in the City of Bloemfontein, District of Bloemfontein.

8. THE EDWARDIAN DWELLING-HOUSE, MAIN STREET, PAARL

*Description:*

The Edwardian dwelling-house together with five (5) metres of surrounding land, situate on certain piece of freehold land in the Municipality and Division of Paarl, called Lot D, portion of part of La Concorde (now known as Erf 3420, Paarl).

9. THE CAPE DUTCH DWELLING-HOUSE, PRINCE ALBERT

*Description:*
