### WAR GRAVES AND NATIONAL MONUMENTS ACT No. 28 OF 1969

#### DECLARATION OF THE STEAM LOCOMOTIVE KNOWN AS *KITTY*, SITUATED ON A PORTION OF THE FARM DOORNFONTEIN 92 IR, DISTRICT OF JOHANNESBURG

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the steam locomotive known as *Kitty*, as described below, to be a national monument.

Bedryfsiektes in Myne en Bedrywe, 1973 (Wet 78 van 1973), verklaar dat die volgende myne met ingang van 1 Junie 1983 ophou om beheerde myne te wees:

(a) Die myn bekend as Hartlands Asbesmyn, op die plaas Hartlands, geleë in die landdrostdistrik Kuruman, Kaap-provinsie, ontgin deur Hartlands Asbestos (Pty) Limited, Posbus 224, Kuruman, 8460.

(b) Die myn bekend as Jebolo Asbesmyn, op die plaas Jebolo 485, geleë in die landdrostdistrik Kuruman, Kaap-provinsie, ontgin deur Jebolo Asbestos Company (Pty) Limited, Bothastraat 19, Kuruman, 8460.

(c) Die myn bekend as Glencairn Quarry, op grond van die Kaapstadse Afdelingsraad te Glencairn, geleë in die landdrostdistrik Simonstad, Kaapprovinsie, ontgin deur Strong and Moore (Pty) Limited, Posbus 18, Tokai, Muizenberg, 7945.

### WET OP OORLOGSGRAFTE EN NASIONALE GEDENKWAARDIGHEDE, No. 28 VAN 1969

#### VERKLARING VAN DIE STOOMLOKOMOTIEF BE- KEND AS *KITTY*, GELEË OP 'N GEDEELTE VAN DIE PLAAS DOORNFONTEIN 92 IR, DISTRIK JOHANNES- BURG

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Oorlogsgrafte en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Gerrit van Niekerk Viljoen, Minister van Nasionale Opvoeding, hierby die stoomlokomotief bekend as *Kitty*, soos hieronder beskryf, tot nasionale gedenkwaardigheid.

*Description*

The steam locomotive known as *Kitty*, being a movable object usually situated at the Rosherville Workshop of the Electricity Supply Commission on the property known as Portion 102 of the farm Doornfontein 92 IR, Tvl. *Kitty* is described as follows: A tank type steam locomotive with a 460 wheel arrangement, built in 1879 by the firm Kitson & Company of Leeds, England, with manufacturer's number 2269. The numbers 13, 47 and 62 have been allocated to it consecutively and at present it again bears the number 13.

*Historical interest*

This well-preserved locomotive was manufactured in 1879 by the firm Kitson & Co. of Leeds, England, and was brought to South Africa shortly afterwards for service in the Natal Government Railways. It is the oldest working steam locomotive in South Africa and the first to complete a century of service. 10/2/983.

*Beskrywing*

Die stoomlokomotief bekend as *Kitty*, synde 'n roerende voorwerp normaalweg geleë in die Roshervillewerkplaas van die Elektrisiteitsvoorsieningskommissie op die eiendom bekend as Gedeelte 102 van die plaas Doornfontein 92 IR, Tvl. *Kitty* word soos volg beskryf: 'n Tenktipe stoomlokomotief met 'n wielrangskikking van 460, in 1879 vervaardig deur die firma Kitson & Company van Leeds, Engeland, met die fabrieknommer 2269. Die nommers 13, 47 en 62 is agter-eenvolgens daaraan toegeken en tans dra dit weer die nommer 13.

*Historiese belang*

Hierdie goedbewaarde lokomotief is in 1879 deur die firma Kitson & Co. van Leeds, Engeland, vervaardig en is kort daarna na Suid-Afrika gebring om in die Natal Government Railways diens te doen. Dit is die oudste werkende stoomlokomotief in Suid-Afrika en die eerste wat 'n eeu se diens voltooi het. 10/2/983.

WAR GRAVES AND NATIONAL MONUMENTS ACT,  
No. 28 OF 1969

BY-LAWS PERTAINING TO THE STEAM  
LOCOMOTIVE KNOWN AS *KITTY*

By virtue of section 18 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), the National Monuments Council has, with the approval of the Minister of National Education, made the by-laws in the Schedule hereto.

## SCHEDULE

1. In this Schedule, unless the context otherwise indicates—

“defined object” means the steam locomotive known as *Kitty*, which is described and declared to be a national monument by Government Notice 880 of 29 April 1983.

“Public Relations Officer” means the Public Relations Officer of the Electricity Supply Commission at Megawatt Park, Maxwell Drive, Sunninghill Extension 3, Sandton, Transvaal.

2. No person shall have access to the defined object—

(a) without the written permission of the Public Relations Officer; and

(b) on a Saturday, Sunday or public holiday as mentioned in the First Schedule to the Public Holidays Act, 1952 (Act 5 of 1952).

3. The Public Relations Officer may, when granting permission to a person in terms of by-law 2 (a), stipulate conditions with regard to—

(a) hours of access to the defined object;

(b) accompaniment of visitors on the site of the defined object; and

(c) photographing of the defined object or any other property belonging to the Electricity Supply Commission.

4. Any person contravening a provision of by-laws 2 and 3 above or failing to comply therewith, shall be guilty of an offence and liable on conviction to a fine not exceeding R100.

WET OP OORLOGSGRAFTE EN NASIONALE  
GEDENKWAARDIGHEDE, No. 28 VAN 1969

VERORDENINGE TEN OPSIGTE VAN DIE STOOM-  
LOKOMOTIEF BEKEND AS *KITTY*

Die Raad vir Nasionale Gedenkwaardighede het, met goedkeuring van die Minister van Nasionale Opvoeding, kragtens artikel 18 (1) van die Wet op Oorlogsgrafte en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), die verordeninge in die Bylae hiervan uitgevaardig.

## BYLAE

1. In hierdie Bylae, tensy uit die samehang anders blyk, beteken—

“omskrewe voorwerp” die stoomlokomotief bekend as *Kitty* wat by Goewermentskennisgewing 880 van 29 April 1983 beskryf en tot nasionale gedenkwaardigheid verklaar is;

“Skakelbeampte” die Skakelbeampte van die Elektrisiteitsvoorsieningskommissie te Megawatt Park, Maxwellrylaan, Sunninghill-uitbreiding 3, Sandton, Transvaal.

2. Niemand het toegang tot die omskrewe voorwerp nie—

(a) sonder die skriftelike toestemming van die Skakelbeampte; en

(b) op 'n Saterdag, Sondag of openbare feesdag genoem in die Eerste Bylae van die Wet op Openbare Feesdae, 1952 (Wet 5 van 1952).

3. Die Skakelbeampte kan, wanneer hy aan iemand toestemming verleen ingevolge verordening 2 (a), voorwaardes stel met betrekking tot—

(a) ure van toegang tot die omskrewe voorwerp;

(b) begeleiding van besoekers op die perseel van die omskrewe voorwerp; en

(c) fotografering van die omskrewe voorwerp of enige ander eiendom behorende aan die Elektrisiteitsvoorsieningskommissie.

4. Iemand wat 'n bepaling van verordeninge 2 en 3 hierbo oortree of versuim om daaraan te voldoen, is aan 'n oortreding skuldig en by skuldigbevinding strafbaar met 'n boete van hoogstens R100.
