The two buildings known as the Sammy Marks and the Kynoch Buildings, situated on portions of the following erven:

- (i) Certain Erf 335, situated on Church Street, in the City of Pretoria;
- (ii) certain Erf 336, situated on Church Street, in the City of Pretoria; and
- (iii) certain Remaining Portion of Erf 337, situated in Church Street, in the City of Pretoria.
