DECLARATION OF THE MAC-MAC WATERFALLS
ON THE FARM GEELHOUTBOOM 565 KT, DISTRICT
OF PILGRIM'S REST

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Gerrit van Niekerk Viljoen, Minister of National Education, hereby declare the property with the Mac-Mac Waterfalls thereon, as described below, situated on the Remainder of the farm Geelhoutboom 565 KT, District of Pilgrim's Rest, to be a national monument.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Oorlogsgrafte en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Gerrit van Niekerk Viljoen, Minister van Nasionale Opvoeding, hierby die eiendom met die Mac-Macwaterval daarop, soos hieronder beskryf, geleë op die Restant van die plaas Geelhoutboom 565 KT, distrik Pilgrim's Rest, tot nasionale gedenkwaardigheid.

Description

The property with the Mac-Mac Waterfalls thereon, described as follows: The figure ABCDEFGA represents 11,4082 hectares of land, being a proclamation site on the Remainder of the farm Geelhoutboom 565 KT, Province of the Transvaal, as indicated on Surveyor's Diagram SG A4464/75, dated 12 September 1975, and filed in the office of the Surveyor-General in Pretoria.

Deed of Transfer T156/1930, dated 13 January 1930 (paragraph 1).

Natural interest

These waterfalls, which drop 65 m in two uninterrupted cascades, as well as the indigenous forest in the kloof below the falls, form an integral part of the natural beauty of the Eastern Transvaal escarpment. 10/2/980.

Die eiendom met die Mac-Macwaterval daarop, soos volg beskryf: Die figuur ABCDEFGA stel 11,4082 hektaar grond voor, synde 'n proklamasieterrein oor die Restant van die plaas Geelhoutboom 565 KT, provinsie Transvaal, soos aangedui op Landmeterskaart LG A4464/75, gedateer 12 September 1975, en geliasseer in die kantoor van die Landmeter-generaal in Pretoria.

BY-LAWS PERTAINING TO THE MAC-MAC WATERFALLS ON THE FARM GEELHOUTBOOM 565 KT, DISTRICT OF PILGRIM'S REST

In terms of section 18 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), the National Monuments Council has, with the approval of the Minister of National Education, made the by-laws in the Annexure hereto.

ANNEXURE

1. In this Annexure, unless the context otherwise indicates—

“Director-General” means the Director-General of the Department of Environment Affairs;

“defined area” means the Mac-Mac Waterfalls, which are defined and declared to be a national monument by Government Notice 304 of 18 February 1983.

2. The Director-General, or any person thereto authorised by him, may, within the defined area—

- (a) erect and maintain toilet buildings, braai places, security fences and notice boards;
- (b) construct, improve and maintain footpaths and look-out posts;
- (c) place rubbish bins and picnic tables;
- (d) plant indigenous trees and shrubs;
- (e) eradicate exotic plants;
- (f) perform any other actions which are not in conflict with the aims of these by-laws.

3. No person shall—

- (a) disturb animals or vegetation in the defined area without the permission of the Director-General;
- (b) scatter litter in the defined area, but may place it in containers provided there for this purpose;
- (c) disturb the soil in the defined area by way of excavations or in any other way;
- (d) light fires in the defined area, except at places constructed for this purpose by the Department of Environment Affairs;
- (e) camp in the defined area;

VERORDENINGE TEN OPSIGTE VAN DIE MAC-MACWATERVAL OP DIE PLAAS GEELHOUTBOOM 565 KT, DISTRIK PILGRIM'S REST

Die Raad vir Nasionale Gedenkwaardighede het, met die goedkeuring van die Minister van Nasionale Opvoeding, kragtens artikel 18 (1) van die Wet op Oorlogsgrafte en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), die verordeninge in die Bylae hiervan uitgevaardig:

BYLAE

1. In hierdie Bylae, tensy uit die samehang anders blyk, beteken—

“Direkteur-generaal” die Direkteur-generaal van die Departement van Omgewingsake;

“omskrewe gebied” die Mac-Macwaterval wat by Goewermentskennisgewing 304 van 18 Februarie 1983 omskryf en tot nasionale gedenkwaardigheid verklaar is.

2. Die Direkteur-generaal, of 'n persoon deur hom gemagtig, kan binne die omskrewe gebied—

- (a) toiletgeboue, vleisbraaiplekke, veiligheidsomheininge en kennisgewingborde oprig en in stand hou;
- (b) wandelpaadjies en uitsigpunte aanbring, verbeter en in stand hou;
- (c) vullishouers en piekniektafels plaas;
- (d) inheemse bome en struik aanplant;
- (e) indringerplante uitroei;
- (f) enige ander handeling verrig wat nie strydig met die oogmerke van hierdie verordeninge is nie.

3. Niemand mag—

- (a) plantegroei of diere in die omskrewe gebied versteur sonder die toestemming van die Direkteur-generaal nie;
- (b) rommel in die omskrewe gebied strooi nie, maar kan dit in houers plaas wat vir dié doel daar verskaf word;
- (c) grond in die omskrewe gebied by wyse van opgrawings of op enige ander manier versteur nie;
- (d) in die omskrewe gebied vure aansteek nie, uitgesonder op plekke wat deur die Departement van Omgewingsake daarvoor ingerig is;
- (e) in die omskrewe gebied kampeer nie;
