

5. THE LATE-VICTORIAN BUILDING SITUATED AT 42A AND 44 BATH STREET, REMAINDER OF ERF 1783, MONTAGU

Description

The late-Victorian building, situated on a portion of the Remainder of Erf 1783, Montagu, in the Municipality and Division of Montagu.
