NATIONAL MONUMENTS ACT, No. 28 OF 1969

DECLARATION OF PROPERTIES TO BE NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Lionel Percival Hercules Mbeki Mtshali, Minister of Arts, Culture, Science and Technology, hereby declare the properties and natural phenomenon as fully described in the Schedule hereto to be national monuments.

SCHEDULE

1. THE LYNMOUTH GLACIAL PAVEMENT, SITUATED ON THE REMAINDER OF THE FARM HOPEWELL 881, RICHMOND DISTRICT 9|2|440|15
Description
 The Lynmouth Glacial Pavement, together with an area bounded in the east by the eastern boundary of the property (being the Baynesfield-Eston Road), in the west by a line parallel to and 500 metres west of the eastern boundary, in the north by the 750 metre contour line and in the south by the 800 metre contour line, situated on the Remainder of the farm Hopewell 881, in the Richmond District, Province of KwaZulu/Natal (previously in the County of Pietermaritzburg, Province of Natal).
 Deed of Transfer T17263/1969, dated 19 September 1969.
2. THE TRANSCVAAL MUSEUM, TOGETHER WITH THE PROPERTY ON WHICH IT IS SITUATED IN PAUL KRUGER STREET, PRETORIA 9|2|258|100
Description
 The Transvaal Museum, together with the property on which it is situated, being non-alienated State land described as Erven 713, 714, 715, 731, 732 and 733, Pretoria.
3. THE PROPERTY WITH THE FORMER NEW REPUBLIC RAADSAAL AND OLD FORT THEREON, IN LAND-DROST STREET, VRYHEID 9|2|448|18
9|2|448|21
Description
 The property with the former New Republic Raadsaal and old Fort thereon, being Subdivision 1 of Lot 997, Vryheid, situated in the Borough of Vryheid, Administrative District of Vryheid, in extent 1 649 (one thousand six hundred and forty-nine) square metres.
 Deed of Transfer T7267/1989, dated 30 March 1989.
4. THE GLACIAL PAVEMENTS AT BUCKLANDS, HERBERT DISTRICT 9|2|038|14
Description
 The site with the glacial pavements thereon, being Erf 266 (a portion of Erf 277), Bucklands Settlement, in the Administrative District of Herbert, in extent 2,4425 (two comma four four two five) hectares, as indicated by the figure A B C D on Surveyor's Diagram SG 472/93, dated 2 August 1993 and filed in the office of the Surveyor-General at Cape Town, and on File 9/2/038/14 in the office of the National Monuments Council in Cape Town.
 Deed of Transfer T825/1994, dated 11 March 1994.
5. THE TOWN HALL IN COMMISSIONER STREET, KRUGERSDORP 9|2|233|3
Description
 The Krugersdorp Town Hall, together with one metre of surrounding land, as well as the paved terrace and the fountain in front of the building, up to Commissioner Street, including the stone wall and four palm trees, situated on Erf 1940, Krugersdorp, in the Krugersdorp District.
 Deed of Transfer G29/1962, dated 14 May 1962.
6. THE PROPERTY, TOGETHER WITH THE BUILDING THEREON, SITUATED AT 26 CHURCH STREET, PRINCE ALBERT 9|2|076|29
Description
 The property, together with the building thereon, being Erf 560, Prince Albert, in the Township of Prince Albert, in extent 1 606 (one thousand six hundred and six) square metres.
 Deed of Transfer T43772/1994, dated 27 June 1994.
7. THE FAÇADE AND STONE BOUNDARY WALLS OF THE ORIGINAL ROELAND STREET GAOL, ROELAND STREET, CAPE TOWN 9|2|084|2
Description
 The façade of the original Roeland Street Gaol and the stone boundary walls on Roeland Street, situated on Erf 113, Vredehoek, in the City of Cape Town, Cape Division.
 Deed of Transfer T11/1872, dated 1 July 1872.
