DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the historic Machine Building, "Staatsartillerie" Stables and western portion of the Main Building, all situate at Defence Headquarters, Pretoria, to be a national monument.

Description

The historic Machine Building, "Staatsartillerie" Stables and western portion of the Main Building, all situate at Defence Headquarters, Pretoria, on Portion 228 (formerly Portion 257) of the farm Pretoria Town and Town Lands 599, situate in the District of Pretoria, Province of the Transvaal, and measuring as such seven decimal six five eight six (7,658 6) morgen.

Certificate of Registered Title 30957/57, dated 12/12/57.

Historical and architectural interest

The historic Machine Building, "Staatsartillerie" Stables and western portion of the Main Building were erected in the eighteen nineties by the Government of the Zuid-Afrikaansche Republiek. The buildings form an important historical and architectural element in the historic portion of Defence Headquarters and are a link with the military history of the Zuid-Afrikaansche Republiek. 10/2/451.
