AMENDMENT OF THE GUIDE PLAN FOR THE CAPE METROPOLITAN AREA: PENINSULA: DU NOON: ERF 20088, MILNERTON

Under section 6A (19) of the Physical Planning Act, 1967 (Act No. 88 of 1967), read with section 37 (1) (d) of the Physical Planning Act, 1991 (Act No. 125 of 1991), I, Lambert Hendrik Fick, Deputy Minister for Regional Affairs hereby amend the Guide Plan for the Cape Metropolitan Area: Peninsula, as made known by Government Notice No. 2468 of 9 December 1988, by changing the designation of Erf 20088, Milnerton, known as Du Noon from "industrial purposes" to "urban development", as indicated by approximation on the map in the accompanying Schedule.
