DECLARATION OF PROPERTIES TO BE
NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Pieter Gabriel Marais, Minister of National

Education, hereby declare the properties as fully described in the Schedule hereto to be national monuments.

4. THE SHELTER WITH ROCK PAINTINGS, SITUATED ON A PORTION OF SUBDIVISION 1 (ELTHAN) OF THE FARM TANDJESBERG 1, DISTRICT OF CLOCOLAN

Description

The shelter with the rock paintings, being a national monument area, in extent 392 square metres, situated on a portion of Subdivision 1 (Elthan) of the farm Tandjesberg 1, in the District of Clocolan, as indicated by the figure A B C D on Survey Diagram SG 427/1992, dated 27 May 1992, filed in the office of the Surveyor-General at Bloemfontein and on File 9/2/308/1 in the office of the National Monuments Council at Cape Town.
