NATIONAL MONUMENTS ACT, No. 28 OF 1969  
DECLARATION OF PROPERTIES TO BE NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Frederik Willem de Klerk, Minister of National Education, hereby declare the properties as fully described in the Schedule hereto, to be national monuments.

**SCHEDULE**

1. THE SO-CALLED DE RUST FARMSTEAD, SITUATED ON THE FARM BOSCHHOEK 385, IN THE DISTRICT OF MIDDELBURG, TRANSVAAL

**Description**

The three national monument sites, inclusive of the so-called De Rust farmstead thereon, consisting of the Victorian farmhouse, the two outbuildings, the entrance gate and the cemetery, namely:

- (i) A national monument site of 8 262 (eight thousand two hundred and sixty-two) square metres of land, situate on the Remainder of Portion 2 of the farm Boschfontein 386, Registration Division IR, Province of the Transvaal, which is described as the figure A B C D A on Surveyor's Diagram SG A 4901/87, dated 1 July 1987; and
- (ii) two national monument sites of 1,7463 (one comma seven four six three) hectares and 1 067 (one thousand and sixty-seven) square metres, situate on Portion 2 of the farm Boschhoek 385, Registration Division IR, Province of the Transvaal, which are described as the Figures A B C D A and C E F C, on Surveyor's Diagram SG A4900/87, dated 1 July 1987.

Both survey diagrams are filed in the Office of the Surveyor-General in Pretoria and on File 2/T/Hei/1 in the Office of the National Monuments Council in Cape Town.

2. THE SITE TOGETHER WITH THE SKANSKRAAL AND VOORTREKKER GRAVE THEREON, SITUATED ON THE FARM KROMFONTEIN 209, DISTRICT OF VENTERSBURG

**Description**

The site, inclusive of the skanskraal and Voortrekker grave thereon, situate on a portion of the Remainder of the farm Kromfontein 209, in the Administrative District of Ventersburg, Province of the Orange Free State, being a national monument site, in extent 4 469 (four thousand four hundred and sixty-nine) square metres, which is described as the Figure A B C D on Surveyor's Diagram SG 98/1987, dated 31 March 1987, filed in the Office of the Surveyor-General in Bloemfontein and on File 4/0/Ven/1 in the Office of the National Monuments Council in Cape Town.

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Frederik Willem de Klerk, Minister van Nasionale Opvoeding, hierby die eiendomme in die Bylae hiervan volledig beskryf, tot nasionale gedenkwaardighede.

**BYLAE**

1. DIE SOGENAAMDE DE RUST-PLAASOPSTAL, GELEË OP DIE PLAAS BOSCHHOEK 385, IN DIE DISTRIK MIDDELBURG, TRANSVAAL

**Beskrywing**

Die drie gedenkwaardigheidsterreine met inbegrip van die sogenaamde De Rust-plaasopstal daarop, bestaande uit die Victoriaanse plaashuis, die twee buitegeboue, die ingangshek en die begraafplaas, te wete:

- (i) 'n Nasionale gedenkwaardigheidsterrein van 8 262 (agt duisend twee honderd twee en sestig) vierkante meter grond, geleë op die Restant van Gedeelte 2 van die plaas Boschfontein 386, Registrasie-afdeling IR, provinsie Transvaal en beskryf as die Figuur A B C D A op Landmetersdiagram LG A4901/87, gedateer 1 Julie 1987; en
- (ii) twee nasionale gedenkwaardigheidsterreine van 1,7463 (een komma sewe ses vier drie) hektar en 1 067 (een duisend sewe en sestig) vierkante meter, geleë op Gedeelte 2 van die plaas Boschhoek 385, Registrasie-afdeling IR, provinsie Transvaal en beskryf as onderskeidelik die Figure A B C D A en C E F C op Landmetersdiagram LG A4900/87, gedateer 1 Julie 1987.

Beide Landmetersdiagramme is gelasseer in die Kantoor van die Landmeter-generaal te Pretoria en op Lêer 2/T/Hei/1 in die Kantoor van die Raad vir Nasionale Gedenkwaardighede te Kaapstad.

**Beskrywing**

Die terrein met inbegrip van die skanskraal en Voortrekkergraf daarop, geleë op 'n gedeelte van die Restant van die plaas Kromfontein 209, in die administratiewe distrik Ventersburg, provinsie die Oranje-Vrystaat, synde 'n nasionale gedenkwaardigheidsterrein, groot 4 469 (vier duisend vier honderd nege en sestig) vierkante meter en beskryf as die Figuur A B C D op Landmetersdiagram LG 98/1987, gedateer 31 Maart 1987, gelasseer in die Kantoor van die Landmeter-generaal in Bloemfontein en op Lêer 4/0/Ven/1 in die Kantoor van die Raad vir Nasionale Gedenkwaardighede te Kaapstad.
