Kragtens artikel 5 (1) (c) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar die laad vir Nasionale Gedenkwaardighede hierby die sogenaamde Môrewag-eiendom, tesame met die herehuis daarop, geleë te Nuttal-Tuine 14, Durban, voorlopig tot nasionale gedenkwaardigheid.

No. 1958**19 September 1986****EXEMPTION OF CERTAIN LAND FROM THE PROVISIONS OF CHAPTER X AND SECTION 139 (1) OF THE MINING RIGHTS ACT, 1967 (ACT 20 OF 1967)**

The Minister of Mineral and Energy Affairs of the Republic of South Africa has, under and by virtue of the powers vested in him by section 158 (1) of the Mining Rights Act, 1967 (Act 20 of 1967), exempted certain land, held under mining title, on the farm Doornkloof 350 IQ, District of Potchefstroom, Mining District of Johannesburg, Province of the Transvaal, as shown on a sketch plan copies of which are filed in the Mining Titles Office, Johannesburg, and in the office of the Mining Commissioner, Johannesburg, under RMT R27/86, from the provisions of Chapter X and section 139 (1) of the said Act, with effects from the date of publication hereof in the *Gazette*.

DEPARTMENT OF NATIONAL EDUCATION**No. 1937****19 September 1986****NATIONAL MONUMENTS ACT, No. 28 of 1969****/PROVISIONAL DECLARATION OF A NATIONAL MONUMENT—THE PROPERTY KNOWN AS MOREWAG, SITUATED AT 14 NUTTAL GARDENS, DURBAN**

In terms of section 5 (1) (c) of the National Monuments Act, 1969 (Act 28 of 1969), the National Monuments Council hereby provisionally declares the so-called Môrewag property together with the manor-house thereon, situated at 14 Nuttal Gardens, Durban, to be a national monument.

Description

The so-called Môrewag property with the manor-house thereon, being the remainder of Lot Kew, Block D, of the Townlands of Durban 1737 (now known as Erf 1737, Durban), situated in the City and County of Durban, Province of Natal, in extent seven thousand five hundred and eighty-seven (7 587) square metres.
